

**AMENDMENT NO. 1 TO CONSULTING SERVICES AGREEMENT BETWEEN
THE CITY OF SAN LEANDRO AND
LARRY WALKER ASSOCIATES
FOR
MUNICIPAL REGIONAL STORMWATER PERMIT (MRP3) COMPLIANCE PLANNING SUPPORT**

This **Amendment No.1** (“Amendment”) is made by and between the City of San Leandro (“City”) and Larry Walker Associates (“Consultant”) (together sometimes referred to as the “Parties”) as of September 1, 2024, and amends that certain Consulting Services Agreement (“CSA” or “Agreement”) dated August 25, 2025 | 10:01:11 AM PDT between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to Municipal Regional Stormwater Permit (MRP3) Compliance Planning Support, and

WHEREAS, the Parties desire to amend the Agreement to add additional work to complete stormwater program development and compliance reporting, which will cost and additional \$170,500.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

1. Section 2 of the Agreement entitled “Compensation” is hereby amended to pay Consultant a sum not to exceed \$219,500 and
2. Exhibit A of the Agreement entitled “Scope of Services” is hereby amended to read:
