Background on Fees

- Fees are charged for specific services (recreation classes, facility rentals, building permits, etc.)
- Fees are intended to recover the costs of services provided
- User fees and service charges are set based on a variety of criteria
- March 2021: Budget Task Force initiative = Update of Fees
- December 2022: Fee Study commenced
- A public hearing is required for fee and tax rate adjustments Master Fee Schedule
- Updated fees are effective July 1, 2024

2019 Prop 218 Study for Wastewater Fees

- Determined whether revenues will be adequate to cover costs
- Recommended bringing single family rates to various levels
- Project delays have contributed to fee implementation being delayed

New Costs for FY 2024-25

- Planning and Design for Nutrient Caps: \$2.0 M
- 348% increase in Hypochlorite (for water disinfection): \$0.5 M
- 48% increase in Biosolids Hauling: \$0.2 M
- Estimated Increasing Staffing Costs: \$0.3 M

Recommendation for FY 2024-25

- Approve fee increases to be set at recommended FY 2023-24 levels (one year behind)
- Staff will commence a new Prop 218 study for future year rates
