## 7. PUBLIC COMMENTS

Drowning Darryl's representative spoke about the swimming program and how the city's increased fees make it difficult for their children to participate in swimming activities. Drowning Darryl's needs support to keep its program going. Drowning Darryl's is asking the city to adjust fees to allow the program to continue.

- A Halcyon Historical Park representative came to give a history of the property and discussed the bird sanctuary that will be destroyed due to the beautify San Leandro project.
- A pickle ball representative came and discussed the sport's importance and how it would benefit the town's growth.
- Comments from the public regarding the fees for the City of San Leandro Recreation and Parks programs. They requested a discussion on the policy surrounding fees.
- Another comment from the public discussed the reservation process and how to reserve the Marina and other parks.

## 8. REPORTS

Commissioners provided updates on their recent visits to various parks. Each commissioner shared their findings, focusing primarily on dogs off-leash, trees down, un housed individuals, light stands near entry gates, open gates, trash containers overflow, skate park, damaged courts, and mulch needed around trees. Floresta Baseball League requests that the Floresta and Bonaire parks restrooms remain open during their games on Tuesdays and Thursdays. Commissioner Mui asked if clearing space at Washington Manor Park for a dog park is possible due to the constant dogs being off their leashes. They also discussed the restrooms being locked early.

**Urban Forest/Tree Master Plan** 

Parks and Landscape Manager Jennifer Auletta reported there is nothing to report on the City's Tree Master Plan.

**Recreation and Parks Master Plan** 

Recreation Services Manager Ely Hwang provided updates on the Recreation and Parks Master Plan. WRT will present at the May commission meeting and

report on the project's progress. WRT will attend the City's open house on April 13, 2024, to network with the community and answer questions.
