4. CITY STAFF REPORTS AND ANNOUNCEMENTS

4.A. City-wide Updates

As part of the biennial budget process, the city leadership has requested that all departments reduce their budgets and consider cost-saving measures. Some important dates include the biennial budget public hearing & adoption at the June 2, 2025 City Council meeting, followed again at the June 16, 2025 City Council if the budget is not adopted on June 2nd.

San Leandro is moving to district-based elections in 2026. The public can learn more by going to the sanleandro.org/vote/votebydistrict webpage, and

access to Q&A during the 5/28/25 Farmer's Market and the 6/2/25 Public Hearing during the City Council meeting.

Mayor González III nominated Dr. Shalini Gopalkrishnan during the May 5th City Council meeting. The appointment is scheduled for confirmation by the City Council during the City Council meeting on May 19th. If confirmed, Dr. Gopalkrishnan will participate in the June 2025 Senior Commission meeting.

4.B. Human Services Department-wide Updates

The Lewelling Interim Housing & Drop-in Center Open House is scheduled for 5/23/25 from 1:00-3:00 p.m. Staff will provide guided tours and answer questions.

Regarding staffing, two Human Services Department part-time staff members (Stephanie and Alice) will end their employment with the City of San Leandro at the end of June 2025. A going-away celebration is scheduled at the end of June.

4.C. Senior Services Updates

The Annual Senior Resource Fair is scheduled for Tuesday, June 24th. The Senior Commission will have a table to share general information regarding the Senior Commission, Age-Friendly Plan, and information about other civic service opportunities.

In support of our Age-Friendly Action Plan, a Chat with the Chief event will take place at the Senior Community Center on May 28th from 8:00-9:30 a.m.

The computers in the computer lab at the Senior Community Center have been replaced.

Staff continue to promote senior services. Recently, staff participated in the Vietnamese American Community Center of the East Bay (VACCEB) Spring Health Fair on April 26th. In addition, staff were at Farmer's Market on April 30th and May 14th.
