

**AMENDMENT NO. 1 TO CONSULTING SERVICES AGREEMENT BETWEEN
THE CITY OF SAN LEANDRO AND
EAST BAY SPCA
FOR
ANIMAL WELFARE SERVICES**

This **Amendment No.1** ("Amendment") is made by and between the City of San Leandro ("City") and East Bay SPCA ("Consultant") (together sometimes referred to as the "Parties") as of July 1, 2025, and amends that certain Consulting Services Agreement ("CSA" or "Agreement") dated July 1, 2023, between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to animal welfare services, and

WHEREAS, the Parties desire to amend the Agreement to extend the term of service.

WHEREAS, Amendment No. 1 to the CSA was approved by the Council on July 21, 2025, per Council Resolution Number 2025-095.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

1. Section 1.1 of the Agreement entitled "Term of Services" is hereby amended to extend the term from June 30, 2025 to December 31, 2025; and
2. Section 2 of the Agreement entitled "Compensation" is hereby amended to pay Consultant a sum not to exceed \$937,500; and
3. Exhibit B of the Agreement entitled "Compensation Schedule & Reimbursable Expenses" is hereby amended to read:

Additional fees for animals over the contract base of 250 per this six-month period will be charged in steps as described below:

<u>251 – 325</u>	<u>\$39,750</u>	<u>\$220,854</u>
<u>326 – 400</u>	<u>\$35,000</u>	<u>\$255,854</u>

4. Except as modified by this Amendment, all other terms shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.


