4. PARK SAFETY AND ENFORCEMENT

Lieutenant Jefferey Walton of the San Leandro Police Department answered inquiries from the commission, regarding public safety enforcement in San Leandro Parks.

A. Commissioner Park Visit Report.

Commissioners reported on their recent park visits. Each commissioner shared their observations and assessments, primarily focused on park areas that require maintenance and programming issues.

B. Park and Open Space Operation and Maintenance Report.

Parks Services Manager Jennifer Auletta reported that there are several park amenities that were built by volunteers in past years which are becoming a challenge to maintain for Parks Services, such as the Thrasher Skate Park and the San Leandro Ball Park Score Board. She also reported that the pickleball/tennis court resurfacing are very close to completion and that the San Leandro Family Aquatic Center is on a timeline for all construction to be completed and the pool to be open for next year's summer season.

6. PUBLIC COMMENTS

Public comment was made in support of more Pickleball courts in San Leandro. An e-comment inquired when the pickleball courts will be open.
