ORDINANCE OF THE CITY OF SAN LEANDRO CITY COUNCIL AMENDING SECTION 2-2-500 OF THE SAN LEANDRO MUNICIPAL CODE RELATING TO AN ANNUAL CPI ADJUSTMENT TO THE BUSINESS LICENSE FEES

WHEREAS, pursuant to Section 2-2-500 of the San Leandro Municipal Code Relating to the Annual Consumer Price Index (CPI) Adjustment to Business License Fees, the City Council desires to increase Business License fees by the Consumer Price Index (All-Urban Consumers, San Francisco Area), which is an increase of 4.9% above the current fees.

NOW, THEREFORE, the City Council of the City of San Leandro does ORDAIN as follow

Section 1. Chapter 2, Title 2, Section 2-2-500 of the San Leandro Municipal Code is amended to reflect a 4.9% annual CPI adjustment, and is thus amended in its entirety to read as follows:

“2-2-500 FEES BASED ON NATURE OF BUSINESS

Every person commencing or carrying on a business within this City shall pay a license fee in an amount determined by the Finance Director in accordance with the nature of the business as hereinafter set forth:

The business license fees established by this Section shall continue to be adjusted annually by an amount equal to the percentage increase in the Consumer Price Index for All Urban Consumers (CPI-U) for the San Francisco-Oakland-San Jose metropolitan area, as published by the U.S. Department of Labor, Bureau of Statistics.”

Section 2. Effective Date.

This ordinance shall take effect July 1, 2023.
