Add to San Leandro Police Department (SLPD) Policy #707 specific language excluding from future acquisition the following equipment categories as defined under AB 481 which SLPD does not currently possess or apparently need: Category #4 (Tracked armored vehicles); Category #6 (Weaponized aircraft of any kind); Categories #8&9 (Firearms and ammunition of .50 caliber or greater); and Category #13 (TASER Shockware, microwave weapons, water cannons and long-range acoustic devices); and 2. DELETE from SLPD Policy 707.7 the section that authorizes the Chief or his/her designee to override the authorized uses of military equipment whenever, in good faith, he/she believes there is an emergency involving the danger of, or imminent threat of, death or serious physical injury to any person or destruction of property.
