



Prohousing Designation Program Scoring Categories

30 points required across four categories – two year implementation timeline:

Category 1: Favorable Zoning and Land Use

Category 2: Acceleration of Housing Production Timeframes

Category 3: Reduction of Construction and Development Costs

Category 4: Providing Financial Subsidies

"Enhancement Factors" extra points for each qualifying policy.


