

**AMENDMENT NO. 1 TO CONSULTING SERVICES AGREEMENT BETWEEN
THE CITY OF SAN LEANDRO AND
CHAPLIN & HILL INVESTIGATIVE SERVICES LLC
FOR
POLICE PROFESSIONAL INVESTIGATIONS**

This **Amendment No.1** ("Amendment") is made by and between the City of San Leandro ("City") and Chaplin & Hill Investigative Services LLC ("Consultant") (together sometimes referred to as the "Parties") as of July 1, 2024, and amends that certain Consulting Services Agreement ("Agreement") dated December 11, 2023, between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to police professional investigations, and

WHEREAS, the Parties desire to amend the Agreement to extend the term of service.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

1. Section 1.1 of the Agreement entitled "Term of Services" is hereby amended to extend the term from June 30, 2024 to June 30, 2026; and

2. Exhibit B of the Agreement entitled "Compensation Schedule & Reimbursable Expenses" is hereby amended to read: Hourly Investigation Rate: \$225.00 per hour, plus any associated expenses incurred as a result of the investigation.

3. All other terms shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
