## 4. CITY STAFF REPORTS AND ANNOUNCEMENTS

#### 4.A. Warming Center Update

The San Leandro winter shelter opened on Tuesday, January 14th, and will be operated by Rising Into Self-Empowerment (RISE). The location is the First United Methodist Church and the hours from 5pm - 7am the following day when the temperature is forecasted to be 42°F or below, and/or when there is a 50% or higher chance of rain. Also, beginning January 14, 2025, through April 30, 2025, the shelter is open every Tuesday, 5pm - 7am, regardless of weather.

#### 4.B. One-Time Food Access Grants Update

The Human Services Department recently released a total of \$200,000 for community food services. There were 14 applicants total and 11 of 14 applicants have been awarded funding.

#### 4.C. CAP Grants Update

The Community Assistance Program (CAP) grant funding availability for the FY26-27 cycle will be \$320,000. An increase from \$160,000 in the last grant cycle. Applications opened on 12/05/24 and are due 1/23/25.

#### 4.D. YearUp Program Update

The current cohort of the YearUp Program concludes on Friday, January 24th. Twelve interns supported the City's work in various departments and roles. The Human Services Department thanks Christian and Leanne for supporting the Department's efforts. Christian and Leanne provided valuable support to grant making, outreach, and data collection.

#### 4.E. Senior Services Update

The IRS's Volunteer Income Tax Assistance (VITA) will be offering no-cost tax preparation to qualified participants. The service will be available by appointment at the Marina and Senior Community Centers. The sessions are by appointment. This service is possible thanks to a partnership with the Alameda County Social Services Agency, VITA, and the City of San Leandro's Human Services and Recreation and Parks Departments.

Naranjo shared that the Commissioner nameplates will be updated and asked everyone to confirm the spelling of their names.
