To protect public safety and the rights of all members of the audience to participate in the meeting, any signs, placards, banners, props, or similar items shall not be attached to any pole, stick, or other device. The items must not be raised above shoulder level whether seated or speaking from the podium, obstruct the view of other attendees or the Council or passage of other attendees.
