## About the report

Each board or commission has a staff member who acts as its secretary. Secretaries track attendance and send the information to the City Clerk's Office. The City Clerk's Office uses this data to create a yearly report for the City Council.

#### **Attendance policy**

The City Council Member Handbook establishes the meeting attendance policy for members of boards and commissions:

- 1. Members of boards or commissions shall be required to attend not less than 75% of all regular meetings held;
- 2. Failure by a member to attend three consecutive regular meetings of a board or commission will be cause for Council declaring the member's position vacant;
- 3. Attendance records will be reviewed by the City Council once a year based on the previous 12-month period, except for appointments effective July 1st or thereafter. <sup>1</sup>

If a member is unable to attend a meeting, the secretary or chairperson must be notified before the meeting.<sup>2</sup>

#### **Report parameters**

This report covers the period of May 2024 to April 2025. While all meetings are included in the report, only regular meetings are counted towards attendance.

In the example shown above, Jane Doe serves on the Senior Commission.

- Five regular meetings were held in the reporting period
- Jane served on the commission for three of the meetings
- Of those three, she was present for two meetings and absent from one

Therefore, Jane's percent of regular meetings attended is 67% (or 2÷3).

Because her attendance has fallen below the required 75%, the % Attendance column is **bolded and italicized**.
