- 6.a. Age-Friendly Initiative and Intergenerational Programming by Mike King with Pear Street Consulting and Liliana Grey, Program Coordinator with the City of San Leandro Human Services Department

Mike King from Pear Street Consulting and Liliana Grey, Program Coordinator with the City of San Leandro Human Services Department, delivered a presentation on the City's Age-Friendly Initiative and its Implementation Plan. The focus of the presentation was on fostering social connections and creating more opportunities for intergenerational programming. Mike King reviewed preliminary ideas for the initiative, highlighting the importance of strengthening social interactions across different age groups. The Youth Advisory Council (YAC) actively participated, offering additional ideas and suggestions to enhance the initiative.

Additionally, Mohamad Abdellatif shared a flyer posted at KIPP King Collegiate High School. Further discussion on these resources and potential partnerships will take place at the next meeting.
