- Limited graffiti abatement on private property

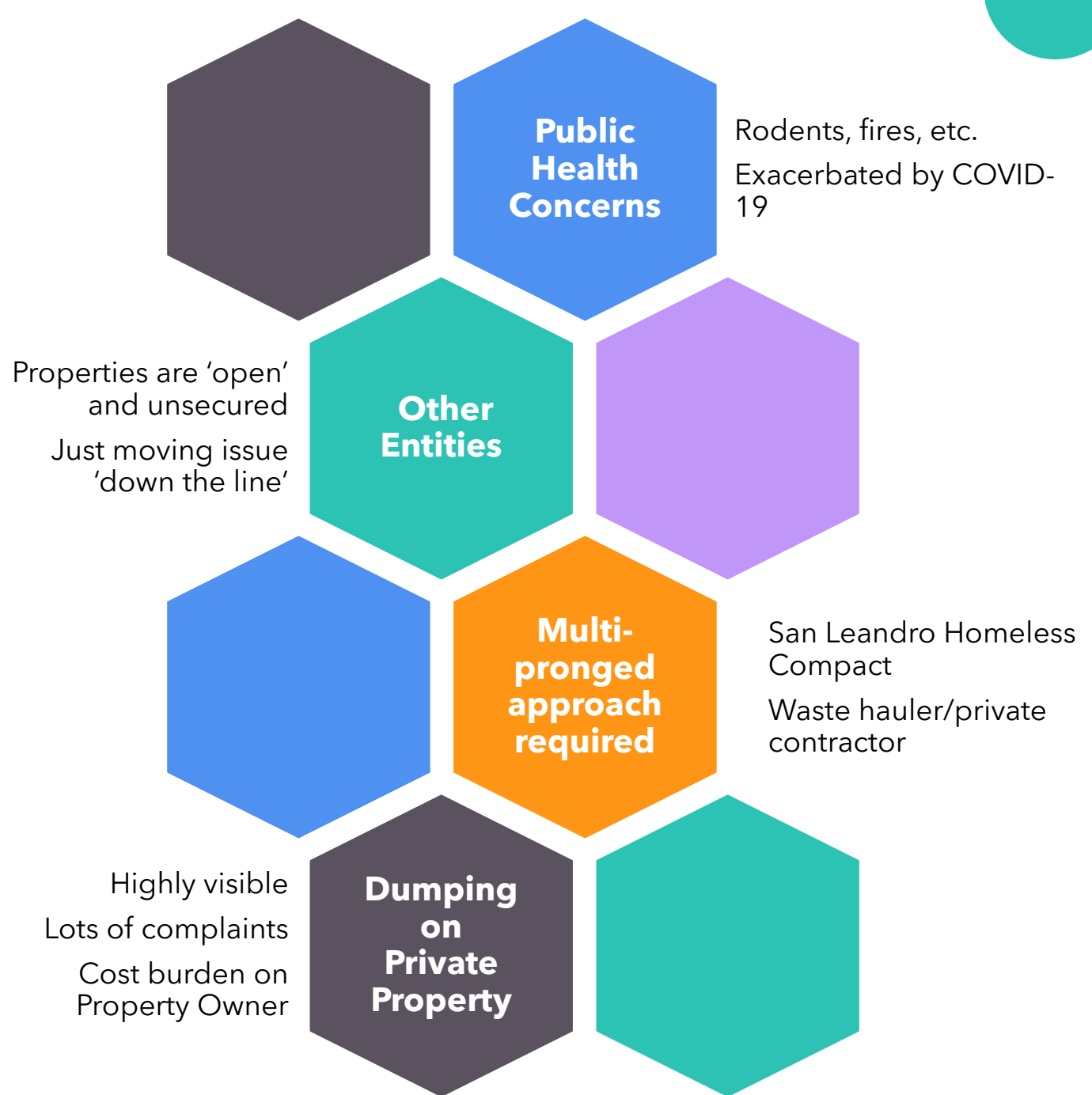
Code Compliance

Options for Consideration



Additional Pick-ups

- Negotiate with ACI & WM
- 18 months for ACI to implement
 - Supply chain delays
- ~\$600K annually

Integrate with MySL

- Alameda
 - Response in ~ 24 hours
 - Bulky items only
 - ~\$1.4M annually
 - Paid by City
 - Program included in ACI Agreement

Reward Program for Reporting

- Oakland
 - Can receive up to ½ of collected penalties

Multiple Curbside Collections

- San Ramon
 - Rotating areas
 - Bulky + reusable
 - Baked into rates
- Livermore
 - 3x/year
 - Baked into rates

Coupons for Residents

- Hayward
 - Dump @ DSTS
 - Issue limited # of coupons monthly
 - Convenience
 - Baked into rates
 - ~\$5K-\$10K/mo if City paid

Rate Remittance

- Fremont
 - Hauler remits \$\$ back to City as pooled funds
 - Used to pay for clean-ups by contractor





Unhoused Population

27.89% of the national total of

Current Efforts

Existing Numbers

- ~ 344 people unhoused in San Leandro

San Leandro Homeless Compact

- Case management partners include:
 - Building Futures
 - Assumption Parish
 - April Showers
 - City staff (RHS & PD)

Downtown Streets Team


- \$400K budgeted in FYs 22 and 23
- Employs San Leandro homeless (vouchers for services)
- Supplements work by SLIA

Downtown Safety Ambassadors

- \$175k budgeted FY22 & 23
- Run by Downtown Community Benefit District (SLIA)
- Respond to quality-of-life issues in Downtown
- Assist unhoused population



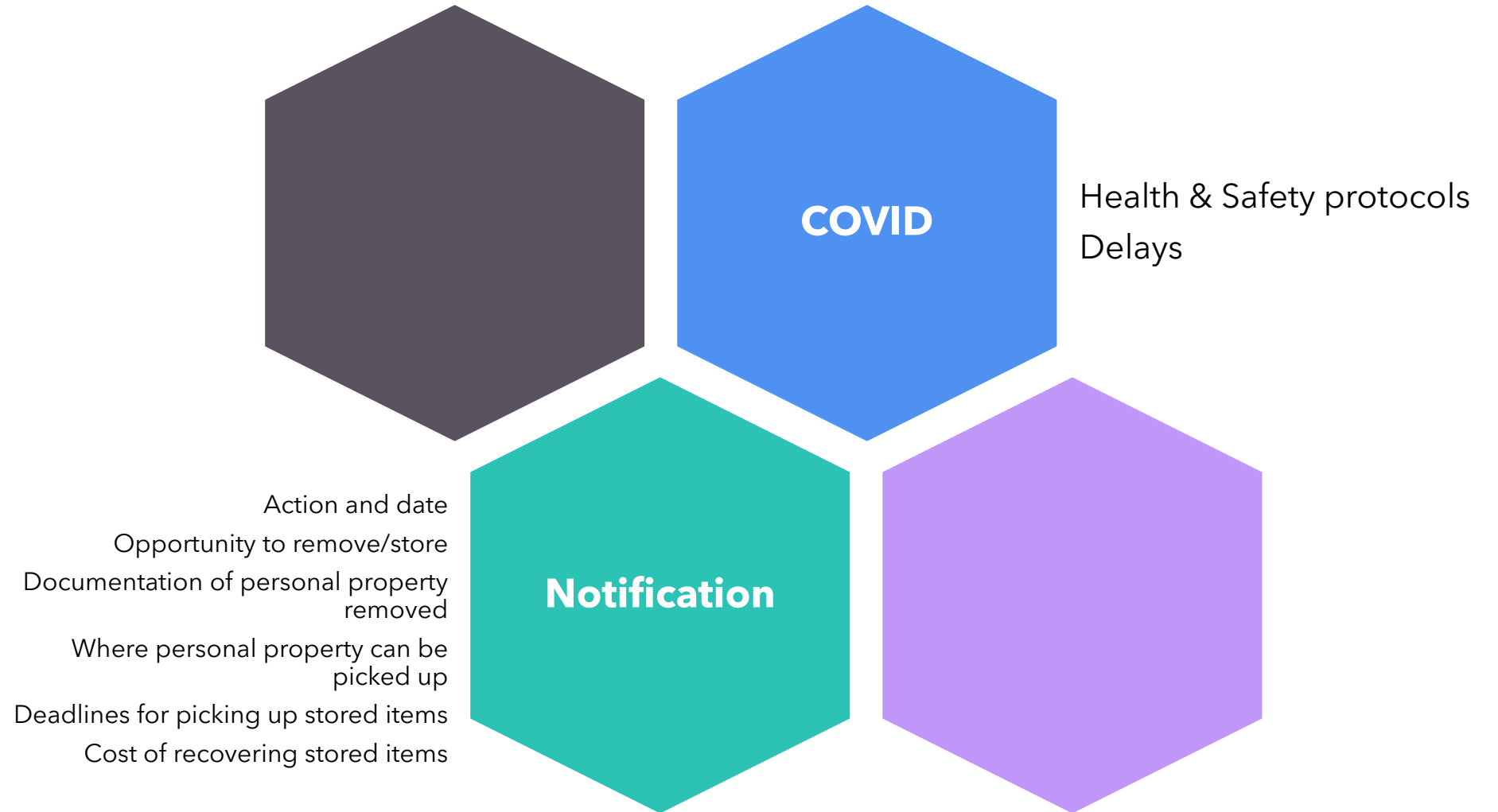
Legal Issues Related to Unhoused and Encampments

- *Martin v. City of Boise (2019)*
 - Prohibits criminal penalties for sitting, sleeping or lying outside on public property
 - Prohibits prosecution when more homeless individuals than available shelter beds
 - *Lavan v. City of Los Angeles (2012)*
 - Notice required prior to removal action
 - Storage of personal property must be provided

Other Issues Related to Unhoused and Encampments

- Size of item (bulky items pick-up) irrelevant
- Strong likelihood that ordinance providing for removal of un-abandoned personal property, with notice and storage, would pass legal muster
- Abandoned person property can be removed without notice and storage

Obstacles/Issues



Options for Consideration

Fremont Model

- Combines encampment + illegal dumping clean-up efforts
- ~\$870K annually for 6 days/month

Pilot DST Model

- Expansion to other City locations
- San José partners with DST and Goodwill of Silicon Valley

Elk Grove Model

- Encampment residents paid to clean up their area
- \$20 gift card every 2 weeks for bagging trash

Project Design & Zoning Reqs

- Right-size trash enclosures for multi-family and non-residential projects
- Fencing, lighting, and barriers to deter

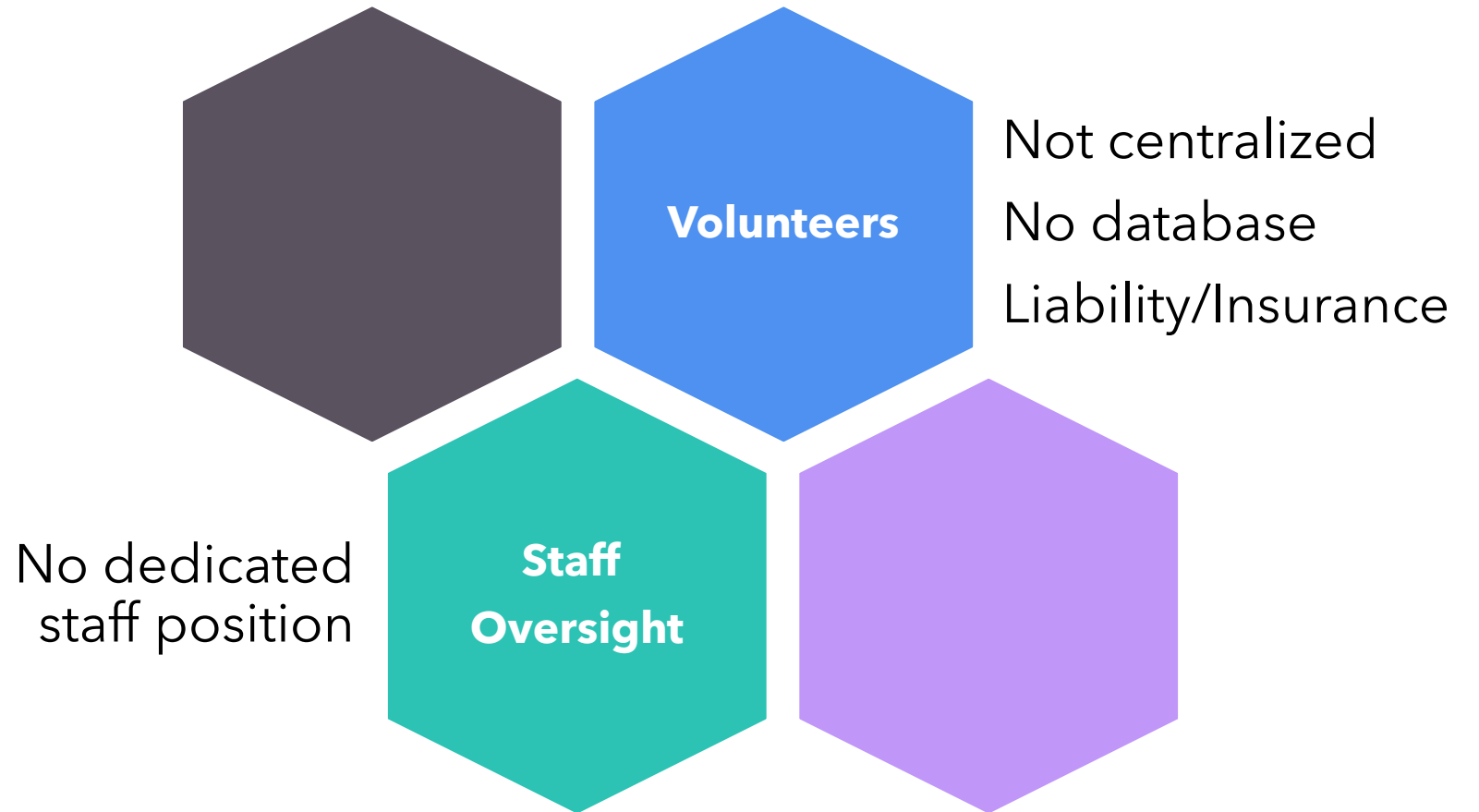
C&D Ordinance

- Incentivizes compliance
- Required by State

Road Map to Address Illegal Dumping

STAGES OF ILLEGAL DUMPING			
Crisis	Dumped	Littered	Clean
Illegal dumping hotspot	Dumping happens regularly & litter is placed on top of it	Litter happens regularly and is the norm	Small amounts of litter
Dumping happens almost daily & abated infrequently	Dumps sometimes picked up but can linger and attracts more dumping	Small dumps happen sometimes & attract more litter	Dumping rarely happens, and is cleaned up immediately
Situation is hopeless		Dumping is cleaned often and rarely piles up	

The Role of Residents, Neighbors, and Community

Organize local residents and businesses to rally around a common cause	Meet regularly, to keep the conversation alive and moving	Continue meeting to maintain momentum and reduce recidivism	Meet and organize cleanups as needed
Advocate with local leaders to raise awareness of the issue and gain their commitment to addressing it	Organize large-scale clean-up events. Invite local leaders, businesses, and residents to participate	Work with local businesses and MF units to ensure properly-sized refuse bins and bulky pickup waivers	Organize 'micro-cleaning' events, to remove small debris, dirt, dust, and grime
Encourage wide-spread use of reporting mechanisms (e.g. MySL)	Report illegal dumps immediately, so that they can be removed quickly	Identify dumping and litter hot spots, so that they can be specifically addressed	Enjoy a clean street

Options for Consideration

Adopt One Block

- Portland
- Similar to City's Adopt-a-Drain
- Online sign-up
- Supplies delivered for free

Love Your Block

- Cities of Service
- 2-year \$25K grant to city (competitive)
- Micro-grants given out
- AmeriCorps VISTA members

Dump Vouchers

- For businesses hit by illegal dumping

Next Steps

- Council to provide direction to staff on which models to further analyze.
- Staff to come back to Council with potential programming details, including costs/staffing requirements for consideration.
- In the interim, staff to continue with existing programs/events.
