- An Ad Hoc Subcommittee composed of Members Gibbs, Zimmerman, and Chang is established and charged with identifying up to three diverse members of the community for the interview panel; and
- The CPRB wishes to invite Emily Griego of the San Leandro Chamber of Commerce, DeWayne Cornelious of the San Leandro Black Chamber of

Commerce, and Erina Kim-Eubanks from Bethel Community church to participate in the interview panel as representatives of the faith-based and business communities.
