

**AMENDMENT NO. 2 TO NON-PROFESSIONAL SERVICES AGREEMENT BETWEEN  
THE CITY OF SAN LEANDRO AND  
MV TRANSPORTATION, INC.  
FOR  
FLEX RIDES SHUTTLE PARATRANSIT SERVICES**

This **Amendment No. 2** ("Amendment") is made by and between the City of San Leandro ("City") and MV Transportation, Inc. ("Contractor") (together sometimes referred to as the "Parties") as of July 1, 2023, and amends that certain Non-Professional Services Agreement ("Agreement") dated July 1, 2020, between the Parties.

**WHEREAS**, City and Contractor have executed the Agreement, pursuant to which Contractor has provided certain services to City with regard to FLEX RIDES Shuttle Paratransit Services; and

**WHEREAS**, the Parties desire to amend the Agreement to extend the term from July 1, 2020 – September 30, 2023,

**NOW THEREFORE**, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

1. Section 1.1 of the Agreement entitled "Term of Services" is hereby amended to extend the term from July 1, 2020, to September 30, 2023; and
2. All other terms shall remain in full force and effect.


This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.


