3.A. [20-179](#) AC Transit Bus Rapid Transit (BRT) - San Leandro Transit Center

- a. Councilmember Lopez asked AC Transit for clarification on whether the deployment wheelchair ramp at the island stop is manually or power-operated by the operator.
- b. Due to the increased litter at San Leandro BART station, Mayor Cutter asked AC Transit if garbage cans would be added back since they were taken out during construction.
- c. With the construction delays, Councilmember Cox asked if AC Transit needed councilmembers to intervene to discuss matters with BART.
- d. Councilmember Lopez asked if operators have room to prepare their meals based on the proposed bathroom floor plan.
- e. Senior Services Recreation Supervisor Susan Criswell asked AC Transit to clarify Paratransit alternative stops as well as Flex and Kaiser shuttle services during construction. Susan will provide vehicle measurements to AC Transit to ensure the size will not compromise the operator with the multimodal design of the shuttle commuter zone with BART.

3.B. [20-180](#) Discussion of the E. 14th Street (North Area) Pedestrian Lighting Project

- b. Mayor Cutter indicated that the council would need to look at the budget closely and to prioritize project funds.
- c. Councilmember Cox also mentioned budget concerns but noted that an economic downturn can result in favorable bids.
- d. Councilmember Lopez suggested looking at the schedule for CIP projects and moving bond funded projects forward to take advantage of potential favorable bidding environments.
