**RESOLUTION TO APPROVE AND AUTHORIZE THE CITY MANAGER TO EXECUTE AGREEMENT AMENDMENTS FOR EACH OF THE EXISTING CONSULTANT SERVICES AGREEMENTS WITH CSG CONSULTANTS, INC., KIER & WRIGHT CIVIL ENGINEERS AND SURVEYORS, INC., AND CSW/STUBER-STROEH ENGINEERING GROUP, INC. FOR ON-CALL CIVIL ENGINEERING AND LAND SURVEYING SERVICES (PROVIDES FOR AMENDING THREE AGREEMENTS FOR AN AMOUNT NOT-TO-EXCEED \$150,000 FOR ONE YEAR PER AGREEMENT, FOR A TOTAL OF \$450,000 ADDED ACROSS ALL THREE CONTRACTS)**

**WHEREAS**, agreements dated July 18, 2022, exist between the City of San Leandro and CSG Consultants, Inc., Kier & Wright Civil Engineers And Surveyors, Inc., and CSW/Stuber-Stroeh Engineering Group, Inc. for On-Call Civil Engineering and Land Surveying Consulting Services; and

**WHEREAS**, a contract amendment is required for each contract to extend the on-call civil engineering and land surveying support services with updated fee schedules for one additional year to June 30, 2027, with a Not-to-Exceed amount of \$150,000 per Agreement; and

**WHEREAS**, amendments to each of the agreements are presented to this City Council; and

**WHEREAS**, a blanket purchase order will be requested for each individual consulting firm as tasks are assigned, with consultant costs being charged to specific projects, each with a designated appropriation; and

**WHEREAS**, the City Council is familiar with the contents thereof; and

**WHEREAS**, the City Manager recommends approval of said amendments to the agreements.

**NOW, THEREFORE**, the City Council of the City of San Leandro does **RESOLVE** as follows:

That said amendments to the agreements with CSG Consultants, Inc., Kier & Wright Civil Engineers And Surveyors, Inc., and CSW/Stuber-Stroeh Engineering Group, Inc. for on-call civil engineering and land surveying support services are approved; and

That the City Manager is authorized to take all actions and execute all documents necessary to effect the purpose and intent of this Resolution for each of the consultant services agreements referred to herein.
