## **7. ACTION ITEMS**

- 7.a. Discussion on Student Immigrant Rights

Secretary Liz Hodgins shared that the City Attorney reviewed the infographic created by Damian Lopez and, with minor edits, it is now ready to be shared. Members discussed printing the informational graphic in poster size for display at the upcoming Outdoor Movie Night, as well as sharing it on social media platforms.

- 7.b. Outdoor Movie Night Planning

The event flyer has been translated into Spanish and Chinese, and Secretary Liz Hodgins submitted a request to have it translated into Arabic. The translated versions are expected to be ready for distribution at the next meeting. Members broke into committees to continue planning for the upcoming event. Each committee met separately to discuss their tasks and later reconvened to report back with action items.

- 7.c. YAC Graduation Stoles

Secretary Liz Hodgins reported that the stoles were ordered and have been delivered. They now need to be embroidered with the YAC logo, with the goal of having them completed by the next meeting.

- 8.a. Report of the Chair

Chair Victoria Bammer reminded members that there are only two more scheduled meetings remaining for the term.

**8.b. Commissioner Reports**

Commissioner Jasmine Pham inquired about the Youth Mini Grants that YAC had administered in past terms. She noted that the Sky Pirates, the Ultimate Frisbee team at San Leandro High School, had greatly benefited from the grant, which enabled students to participate in a variety of games and activities.

**8.c. Liaison Representative Reports**

Fedroa Lei reported on the April 7, 2025, City Council meeting, highlighting several key items, including a proclamation declaring April 2025 as National Autism Awareness Month, an appointment to the Bicycle and Pedestrian Advisory Commission, and a resolution to procure and install privacy pods for study at the Main Library, and a comment made during the meeting that emphasized the need for increased Asian representation.

Jasmine Pham reported on the April 21, 2025, City Council meeting, highlighting several key items, including a Proclamation to Declare April 22, 2025 as Earth Day and a presentation on the trash Free San Leandro Initiative. She noted that it is evident San Leandro cares about the environment and sustainability.

Commissioner Emilio Piñones Campos will attend the Recreation and Parks Commission meeting on May 7, 2025, as well as the City Council meeting on May 19, 2025, and will report back at the next meeting.
