**Please Note:** The following budget/estimate is being provided according to the pricing established under the Master Intergovernmental Cooperative Purchasing Agreement (MICPA) with Racine County, WI and OMNIA Partners, Public Sector (U.S. Communities). The line item pricing breakdown from Attachment C: Bid Form should be viewed as the maximum price an agency will be charged under the agreement. Garland/DBS, Inc. administered an informal competitive process for obtaining quotes for the project with the hopes of providing a lower market-adjusted price whenever possible.

#### Scope of Work: Poll Barn

- 1. Remove and dispose of all roofing, flashings, and sheet metal down to structural deck.
- 2. Inspect deck and perform repairs as needed.
- Install clips per ASCE-7 wind uplift calculations over open purlins. Use continuous clips where/if
  needed for wind uplift calculations. Use shims where necessary to ensure a level surface for
  panels.
- 4. Install 4" box gutters and downspouts using Garland Flat Stock.
- 5. Install 0.040 aluminum R-Mer Span continuous panels and seam caps.
- 6. Install all trim metal and detail metal for a complete system.
- 7. Run electic seamer once all work is installed in order to provide a complete warrantable system.
- 8. Roof system shall provide a 30 year NDL warranty and 5 year contractor workmanship warranty.

### Scope of Work: Burt and Jonny

- 1. Remove and dispose of all roofing, edge metal, counter flashing, gutters, downspouts and associated materials.
- 2. Replace all turbine vents with new aluminum turbine vents.
- 3. Inspect deck and perform repairs as necessary. Contractor to provide line items for any additional work regarding deck replacement and fascia board replacement not included in the base bid.
  - a. Bid shall include:
  - i. \$5,000 worth of plywood decking replacement.
- 4. Loose lay red rosin paper.
- 5. Mechanically fasten ½" Densdeck Prime per manufactures wind uplift calc.
- 6. Install StressBase 80 in Garlastic KM Plus hot asphalt.
- 7. Install KEE-Stone FB single ply in Garlastic KM Plus hot asphalt.
- 8. Install all new base flashings with SB 80 and KEE-Stone. Install term bar and new coping metal using Garland Flatstock.
- 9. Install new factory painted .040 aluminum gutters and downspouts using Garland flatstock.
- 10. Install all new lead flashing and detail flashing on roof level details.

- 1. Remove and dispose of all roofing, edge metal, counterflashing, and associated roof material down to structural deck.
- 2. Inspect deck and perform any repairs as needed.
- 3. Adhere ½" asphalt coated wood fiberboard per manufacturers ASCE-7 Wind Uplift Calcs.
  - a. Note: provide line item cost for taper providing 1/4" slope. (see below)
- 4. Install 2 ply StressPly system in Weatherking Plus WC. Allow roof to cure 30 days before coating.
- 5. Install new drip edge/fascia using .040 aluminum flat stock and cleat.
- 6. Install new flashings, expansion joints, and associated details for a completely watertight system.
- 7. Apply Title 24 approved Pyramic Plus LO in 2 coats of 1.5 gallons per 100 square feet once system is fully cured after 30 days.

- 1. Remove and dispose of all roofing, edge metal, counterflashing, and associated roof material down to structural deck.
- 2. Remove items indicated on the provided aerial. Cover gaps in deck with new 18 ga. Steel plate fastened.
- 3. Install wood nailer at parapet coping location.
- 4. Raise all curb flashings to a mimum 8" base flashing height.
- 5. Inspect deck and perform any repairs as needed.
- 6. Adhere ½" asphalt coated wood fiberboard per manufacturers ASCE-7 Wind Uplift Calcs.
  - a. Note: provide line item cost for taper providing 1/4" slope. (see below)
- 7. Install 2 ply StressPly system in Weatherking Plus WC. Allow roof to cure 30 days before coating.
- 8. Run membrane up and over parapet wall.
- 9. Install new flashings, and associated details for a completely watertight system.
- 10. Install new coping using 0.040 aluminum flat stock.
- 11. Apply Title 24 approved Pyramic Plus LO in 2 coats of 1.5 gallons per 100 square feet once system is fully cured after 30 days.

- 7. Run electic seamer once all work is installed in order to provide a complete warrantable system.
