- Ask for Nominations
 - Majority (4) wins Immediate Nomination
 - Vote to Appoint
 - Motion/Second to Appoint
 - Majority (4) Yes Votes
 - Appointed and Sworn In
- No Majority for Nominees
 - Random Order Vote
 - Council Discussion on Nominees
 - Clerk create random voting order for Nominees
 - Vote taken in random order
 - First Nominee to reach 4 Yes Votes Wins Appointment
- No Majority Nominee
 - Call for Special Election

Special Election

City Charter

Section 605

A special municipal election may be held on any date specified by the Council.



Appointment does not occur within 60 days of vacancy

Section 250

The Council shall call a special election, at which the unexpired remainder of the term of the District 1 office shall be filled by the voters.

Cal Gov Code § 36512

The election code requires Election day be a minimum 114 days after the call of the special election, if the City Charter does not have a set timeline

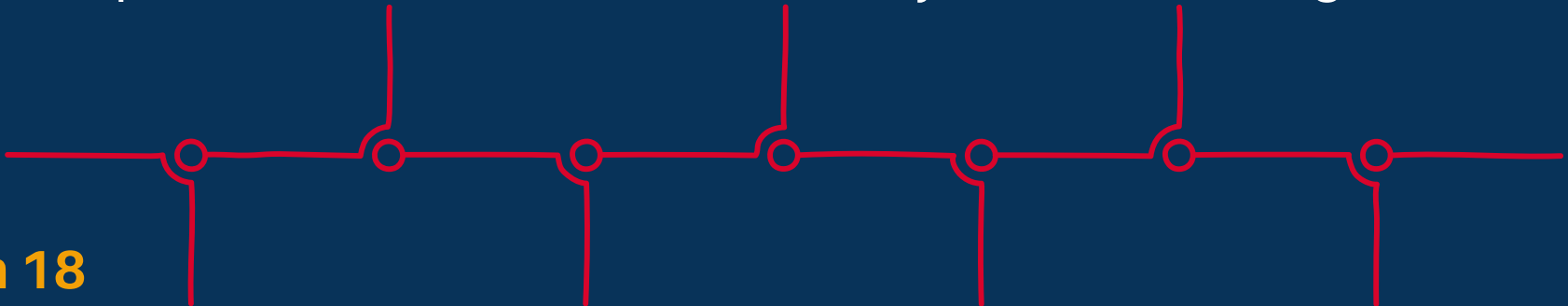
