RESOLUTION NO. 2018-004 of the Planning Commission of the City of San Leandro, Recommending the City Council Adopt an Ordinance Amending Article 6, Division 2 of the San Leandro Zoning Code, Related to the Development Regulations of Commercial and Professional Zoning Districts.

Planning Manager Andrew Mogensen presented and answered clarifying questions.

A motion was made by Vice Chair Brennan, seconded by Chair Pon, that the Planning Commission Adopt Resolution No. 2018-004. The Planning Commission motioned to recommend Council approval of the staff recommended zoning code amendments with an exception to include a provision to allow a 50 foot height limit for P-zoned parcels greater than 10,000 square feet that are surrounded on all sides by other zones with a 50 foot height limit.

9. MEMBERS' COMMENTS

Commissioner Collier had questions regarding Accessory Dwelling Units (ADUs) and was directed to the City Staff for the answers.

Vice Chair Brennan requested people go to the MTC website to view the MTC Horizons Long Range Planning Awards received for some very impactful and

forward looking ideas to help ease transportation problems.

10. STAFF UPDATES/PROJECT STATUS REPORT

In response to Vice Chair Brennan's question regarding when the City planned to do a full zoning code update, Secretary Mogensen stated the project has been proposed to Council and the next update to the zoning code would accommodate the Bay Fair TOD plan.

Secretary Mogensen stated that there are potentially two, maybe three, items scheduled for the Planning Commission meeting on December 20, 2018.

Secretary Mogensen also pointed out that one of the items on the Consent Calendar for the Council meeting on November 19, 2018 is an Ordinance in the Municipal Code to allow concurrent Planning Commission and Board of Zoning Adjustment positions and the other item is a Resolution to end the term of everyone whose term ends in 2020 for Planning Commission and Board of Zoning Adjustments. Planning Commission and the Board of Zoning Adjustments will remain to serve in their current capacity until the new people are sworn in.

Planner II Wu, gave an update on the project located at 1188 East 14th Street.

Vice Chair Brennan mentioned that during the development of the most recent revision of the General Plan, it was mentioned that we really needed to look at it with a technology refresh in mind, including things such as autonomous vehicles.

Secretary Mogensen replied that the Council recently adopted the Fiber Optic Master Plan. He stated that other projects are also in progress with the City's Information Services and Economic Development Departments.
