### 7.A. Cooling Center Update

The City is collaborating with Housing Consortium of the East Bay and Church of Christ to open a cooling center. The site is Church of Christ located at 601 MacArthur Blvd. in San Leandro. Times are 11:00-5:30 p.m. on days when the temperatures are forecasted to be 90 degrees or higher and/or 201 and above Air Quality Index (AQI). The daily capacity at the site is 25 people. Two meals will be served. Lunch on site and dinner to go.

### 7.B. Age Friendly Initiative Update

The contract with the consultant selected via the Age-Friendly Assessment and Action Plan RFP process has been negotiated and is currently being processed. We expect that the contract will be executed in the next few weeks with a start date of November 2023. The name of the contracted consultant will be released once the contract has been executed.

### 7.C. Mercy Brown Bag Volunteers Needed

Volunteers are needed to support our Mercy Brown Bag program. Human Services Department staff and volunteers conduct the food distribution programs the second and fourth Monday of the month at the Senior Community Center and the second and fourth Tuesday at the Marina Community Center.
