## 6. CHERRY FESTIVAL 2023 ELY HWANG, RECREATION DIVISION MANAGER

#### 7.A. COMMISSIONER PARK VISIT REPORT

•Commissioner Wagner reported that all the parks he visited were in generally good shape despite the recent stormy weather. He expressed concerns that the trees at Washington Manor Park needs trimming and that some of the parks he visited had empty pet waste bag dispensers.

•Commissioner Moore reported that on her recent visit at Memorial Park, she noticed that the trees were cut.

•Vice Chair Kline also expressed concerns regarding the trees at Washington Manor Park and commented that it is now somewhat difficult to use the pet waste bag dispensers due to a mechanism that was installed that grips the bags tightly.

# 7.B. PARK AND OPEN SPACE OPERATION AND MAINTAINANCE REPORT JENNIFER AULETTA, PUBLIC WORKS DEPUTY DIRECTOR

•Public Works Deputy Director, Jennifer Auletta reported that the construction on the pickle ball court/tennis court resurfacing at Washington Manor Park will start in mid-May.

•The Heath Court pickle ball/tennis court resurfacing will be delayed due to the vegetation issue around the court. A new contract agreement will need to be established later for the construction of the project.

- •The recent series of storms caused flooding at Stenzel Park and Marina Park. Chabot Park had to be closed due to significant tree damage.
- •The shade sails at Marina Park group picnic sites were damaged due to the high winds.
- •The eucalyptus trees at Memorial Park were topped for safety reasons. A similar type of tree fell during the recent storms and damage one of the San Leandro Creek's foot bridge.
