AMENDMENT NO. 2 TO CONSULTING SERVICES AGREEMENT BETWEEN THE CITY OF SAN LEANDRO AND FEHR & PEERS FOR

ON-CALL TRANSPORTATION ENGINEERING CONSULTING SERVICES

This Amendment No. 2 ("Amendment") is made by and between the City of San Leandro ("City") and Fehr & Peers ("Consultant") (together sometimes referred to as the "Parties") as of ______,2022 and amends that certain Consulting Services Agreement ("Agreement") dated May 15, 2017, between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to on-call transportation engineering consulting services, and

WHEREAS, the Parties executed an Amendment #1 to the original Agreement for Consultant to extend the contract time period to June 30, 2022, and

WHEREAS, the Parties desire to extend the end date of the Agreement.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

- 1. Section 1.1 of the Agreement entitled "Term of Services" is hereby amended to extend the term from June 30, 2022 to June 30, 2023; and
- 2. Exhibit B of the Agreement entitled "Compensation Schedule & Reimbursable Expenses" is hereby amended to read:
