

**AMENDMENT NO. 2 TO CONSULTING SERVICES AGREEMENT BETWEEN  
THE CITY OF SAN LEANDRO AND  
ACTIVWAYS ENGINEERING  
FOR  
VARIOUS ENGINEERING ASSIGNMENTS RELATED TO THE  
IMPLEMENTATION OF THE CITY'S CAPITAL IMPROVEMENT PROGRAM**

This **Amendment No.2** ("Amendment") is made by and between the City of San Leandro ("City") And Activeways Engineering ("Consultant") (together sometimes referred to as the "Parties") as of \_\_\_\_\_, 2026, and amends that certain Consulting Services Agreement ("Agreement") dated April 19, 2024, between the Parties.

**WHEREAS**, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to Various Engineering Assignments related to the implementation of the City's Capital Improvement Program; and

**WHEREAS**, Section 8.3 Amendments, of the Agreement allows the Parties to amend the Agreement provided that the amendment is in writing signed by the Parties; and

**WHEREAS**, on December 24, 2025, the Parties executed Amendment No. 1 to the Agreement to extend the term of the Agreement for an additional one (1) year to December 31, 2026; and

**WHEREAS**, the Agreement is for a "Not-to-Exceed" amount of Ninety-Eight Thousand Five Hundred Dollars (\$98,500.00); and

**WHEREAS**, the Parties desire to amend the Agreement, Section 2, Compensation, to increase the "Not to Exceed" compensation amount; and

**WHEREAS**, City staff is authorized to execute this Amendment in a form approved by the City Attorney.

**NOW THEREFORE**, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

1. Section 2, Compensation, of the Agreement is hereby amended to increase the "Not-to-Exceed" compensation by \$101,500 for a total "Not-to-Exceed" amount of Two Hundred Thousand dollars (\$200,000.00); and

2. With the exception of the foregoing, all other terms and conditions in the Agreement shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
