LEGAL DESCRIPTION
RIGHT-OF-WAY TO BE VACATED

THAT CERTAIN REAL PROPERTY SITUATE IN THE CITY OF SAN LEANDRO, COUNTY OF ALAMEDA, STATE OF CALIFORNIA, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEING A PORTION OF THE RIGHT OF WAY OF EDEN ROAD, A 50-FOOT-WIDE STRIP OF LAND, AS DESCRIBED IN THAT CERTAIN DEED RECORDED SEPTEMBER 1, 2005, AS DOCUMENT NO. 2005-378016, ALAMEDA COUNTY RECORDS;

COMMENCING AT A CITY OF OAKLAND MONUMENT LOCATED AT THE INTERSECTION OF THE EXTENSION OF THE NORTHERLY LINE OF SAID EDEN ROAD AND THE MONUMENT LINE OF DOOLITTLE DRIVE, AS SHOWN ON THAT CERTAIN RECORD OF SURVEY NO. 840, FILED FOR RECORD ON AUGUST 16, 1989, IN BOOK 14 OF RECORD OF SURVEYS, AT PAGE 55, ALAMEDA COUNTY RECORDS;

THENCE ALONG THE SAID EXTENSION, AND THE NORTHERLY LINE OF EDEN ROAD SOUTH 69° 35' 17" WEST, 162.50 FEET, TO THE **POINT OF BEGINNING**;

THENCE LEAVING SAID NORTHERLY LINE, SOUTH 20° 24' 43" EAST, 50.00 FEET, TO A POINT ON THE SOUTHERLY LINE OF SAID EDEN ROAD;

THENCE ALONG SAID SOUTHERLY LINE, SOUTH 69° 35' 17" WEST, 996.10 FEET;



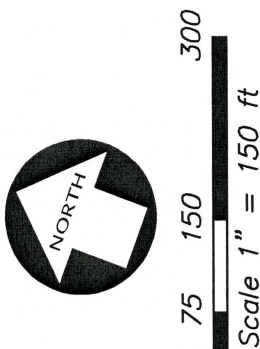
