6.A. COMMISSIONER PARK VISIT REPORT

•Commissioners' Park Visit Reports. Commissioner Wagner reported that the water that pooled at Marina Park during the recent storms has been pumped out, however, it is now a mud pit. He also reported that the Washington Manor Middle School field and Bonaire Park are in good condition and seem to be little affected by the storms.

•Commissioner Moore reported that the slide at Memorial Park has been fixed.

•Vice Chair Kline reported that there was flooding at Washington Manor Park, that pet owners are not picking up after their pets, and that the no smoking signs by the Kiddie Kollege building are not effective.

- Commissioner Ouborg reported that the Friends of the San Leandro Creek completed a creek cleanup at Chabot Park, however, due to the recent storms the park is closed. She also reported that there was a tree-cutting operation at Memorial Park.

**6.B. PARK AND OPEN SPACE OPERATION AND MAINTAINANCE REPORT

- Park Maintenance Staff has been busy at the parks due to the storms.
- Chabot Park will need to be evaluated for safety before it can open.
- Plans are being made for the rehabilitation of the turf at Marina Park.
- Dr. Mok Sustainability Manager for the City of San Leandro is working on a common vision to plant 5000 trees in San Leandro.

**6.C. TENNIS COURT RESURFACING/PICKLEBALL COURTS PROJECT
PROGRESS REPORT**

- The Pickleball court rehabilitation process at Washington Manor Park is in the last stages, a purchase order has been requested and a timeline of construction should be available soon.
- Heath Court Pickleball rehabilitation is delayed due to tree issues.
