San Leandro 2050 understands that the City has pre-allocated specific budgets for the two roles identified in the RFP 1) The Grant Coordinator and 2) The Community Facilitator as well as \$25,000* (see notes) in pass-through funds for community participation. This proposal combines both roles under one coordinated contract to improve efficiency, reduce administrative burden, and ensure that communication, reporting, and community engagement move in sync.

The internal allocation below reflects how San Leandro 2050 would manage and report expenditures within the total amount budgeted by the City for the two positions, while maintaining clear deliverables and accountability.

The Community Engagement Fund is estimated at \$30,000 to ensure adequate compensation for both neighborhood hosts and anchor partner organizations. This adjustment strengthens participation across multiple neighborhoods while remaining consistent with the total funding levels allocated by the City for these positions
