#### 4. CITY STAFF REPORTS AND ANNOUNCEMENTS

This report, presented by Gloria Kim, Recreation Services Manager, highlighted that summer camp registration exceeded 1,600 participants, with additional camps released to meet demand, and provided updates on upcoming community events including the Egg Hunt on March 28, Cinco de Mayo on May 1, the Cherry Festival on June 6, and the July 7 Marina Park event. She also noted ongoing community partnership efforts, the proposed pickleball reservation fees starting July 1, and progress on the Community Clean-Up Program.

Jennifer Auletta, Parks and Landscape Manager, reported that Parks and Urban Forestry is entering peak reservation season, with parking enforcement returning this summer, and shared updates including progress on the National

Fitness Campaign, new shade sails, planned replacement of the Cherry Grove playground, and ongoing tree planting donation efforts. She also noted that repainting the Washington Manor courts for pickleball is currently on hold while collaboration opportunities with local schools are explored.
