



## **Art Display at the San Leandro Senior Community Center**

The San Leandro Senior Commission will approve art displays at the Senior Community Center. With rare exceptions, the display area is not intended for one-artist shows. Guidelines for art selection and artists' responsibilities are as follows:

- Arts and crafts exhibiting professional excellence in various media are accepted. Art will be selected with the intent to display the creativity and cultural diversity of Bay Area art, and/or to foster public education and appreciation of the arts.
- Art displays will not discriminate in favor of one viewpoint at the expense of another.
- Art that is legally obscene or involves child pornography is not permitted.
- Artwork with significant violent themes or overtly sexual content is not permitted.
- The artist is responsible for his/her own insurance. The City of San Leandro, the San Leandro Recreation and Human Services Department, and the San Leandro Senior Commission are not responsible for damage to, loss of, or theft of artwork.
- Art must be able to be hung in the designated display area.
- Art hung on the wall display area is to be professionally presented/framed, wired and ready to be hung. The artist is responsible for framing his/her own material.
- The artist is responsible for the transportation of their artwork to and from the facility for delivery and pick up. Artwork not picked up within two weeks of the end of the art show will become property of the City of San Leandro and released at its discretion.
- Exhibits will display for one month or as mutually agreed upon, from the first to the last day of each calendar month. Any one group may exhibit no more than twice a year, with a sixty-day period between events. Exceptions may be made if all months are not booked.
