7. ORAL REPORT OF THE SECRETARY

7.A. Human Services Department staff updates

The Human Services Department has filled three positions since the last meeting. Deveon Remaker is the Human Services Program Coordinator supporting homeless efforts. Liliana Gray is the Human Services Program Coordinator supporting Senior Services, and Alicia Peterson is the new Administrative Assistant. Liliana Gray was present and provided a brief introduction of herself and her role.

7.B. Administrative Code update

Naranjo provided clarity regarding Section 23.1.305, which pertains to the agenda. Naranjo shared that there will be a agenda to guide the meeting, but the structure will change and will be standardized for all City meetings. Naranjo shared the general agenda structure.

The City Clerk's Office will update the Boards and Commissions Handbook in the fall, which will include these changes. The handbook will align with the Council Handbook, similar in information but relevant to Boards and Commissions. The current agenda structure will remain until the City Clerk makes the changes.

Regarding clarity with Section 23.1.410, which pertains to members of the public addressing the Commission, members of the public are not required to state their name or residency. A person appearing in a representative or professional capacity shall state the name of the individual or organization.

7.C. Homeless updates

Regarding this year's warming shelter, the Human Services Department released two related RFIs (Request for Information). One to solicit applications for an organization to host a warming shelter. The deadline to respond is September 30, 2024. The second RFI to identify an operator that will run the program. The City has \$180,000 available to support this program. Responses are being accepted through September 27, 2024.

Regarding data pertaining to homeless seniors, Naranjo recommended that the Commission schedule a presentation to include data as part of a broader homeless presentation that will allow opportunity to review and discuss the findings of the latest Point-in-Time Count.

7.D. Upcoming Human Services Department outreach and presentations

Naranjo provided an update regarding recent outreach and presentations to support Age-friendly Action Plan Priority #1 (Plan Sustainability), which

includes improve communications and outreach about existing resources and services. The following outreach efforts have recently been conducted: outreach at the Downtown Farmer's Market, the City of San Leandro Health & Wellness Fair, the VACCEB Resource Fair, and presentations to a mono-lingual Spanish speaking group, Human Services Commission and the Resilience Hub.

7.E. Annual Thanksgiving Day Lunch update

This year the Thanksgiving Luncheon will be hosted in collaboration with Spectrum Community Services. Registration starts on October 4th. There will be opportunities to volunteer for those interested.

7.F. Upcoming senior events and programs

Naranjo shared that September 22nd through the 26th is Fall Prevention Awareness Week. Spectrum will host a Fall Prevention Awareness Walk on Tuesday, September 24, 2024 from 10:30-12:30 at the San Leandro Marina Park.
