RESOLUTION OF THE CITY OF SAN LEANDRO CITY COUNCIL TO APPROVE FIVE (5) COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) AGREEMENTS TOTALING \$141,342 FOR FISCAL YEAR 2023-2024 BETWEEN THE CITY OF SAN LEANDRO AND CDBG SUB-RECIPIENTS FOR PUBLIC SERVICES GRANTS TO CALICO (CHILD ABUSE LISTENING, INTERVIEWING, AND COORDINATION CENTER) FOR \$22,000; DAVIS STREET FAMILY RESOURCE CENTER FOR \$30,000; SERVICE OPPORTUNITIES FOR SENIORS, INC. (SOS/MEALS ON WHEELS) FOR \$39,000; SPECTRUM COMMUNITY SERVICES (SAN LEANDRO SENIOR NUTRITION PROGRAM) FOR \$30,342; ECHO HOUSING FOR \$20,000
