American Rescue Plan Act (ARPA) Projects


American Rescue Plan Act of 2021

- American Rescue Plan Act (ARPA) Signed Into Law March 11, 2021
 - \$1.9 Trillion Total
 - \$350B to states and local governments
 - \$65B to counties
 - \$65B to cities



Local Fiscal Recovery Funds

- Payments to Local Governments
 - First tranche 60 days after enactment
 - Second tranche 12 mo. after first tranche
- San Leandro Allocation \$18.6M
 - First tranche received in FY20-21
 - Second tranche received in FY21-22

Eligible Uses of ARPA Funding

□ COVID-19 Response

- Services to contain and mitigateCOVID-19
- Behavioral healthcare services including crisis intervention, mental health/substance abuse treatments, and services to promote access to social services

Negative Economic Impact

- Assistance to households
- Support for small businesses and nonprofits
- Support to impacted industries such as tourism, travel, and hospitality sectors

Eligible Uses of ARPA Funding (Cont'd)

- Premium Pay for Essential Workers
 - Can be used retroactively
 - Offering additional support to those who will bear the greatest health risks (workers at food production facilities, grocery stores, janitors/sanitation workers, warehouse workers, truck drivers, etc.)
- Revenue Recovery
 - Government services directly provide services or aid to citizens
 - Infrastructure including maintenance
 - Fire, police, or public safety

Note: This is a more flexible funding category

Eligible Uses of ARPA Funding (Cont'd)

- Investments in Water, Sewer, and Broadband
 Infrastructure
 - Make necessary improvements to support vital clean water, wastewater, and stormwater infrastructure
 - Build broadband infrastructure with modern technology providing reliable download and upload speeds
 - Assist household to support internet access or digital literacy



Ineligible Uses and Timeframe

Ineligible Uses

- Fund pension deposits
- Replenish reserves/rainy day funds
- Pay for debt service payments, legal settlements, or judgements
- Offset reductions in taxes

Eligible Costs Timeframe

- Covered period is March 3, 2021-December 31, 2024
- Costs can be incurred by December 31, 2024, or December 31, 2026 if funds are obligated by December 31, 2024

Compliance and Reporting Requirements

- Funds are subject to audit
- Quarterly expenditure report submission

Approved Funding Allocations

- Reflect short-term community and economic recovery efforts
- □ Focus on long-term sustainable investments in San Leandro
- Align with community values

Community Advisory Budget Task Force Recommendations

Mission and Outcome

- Develop an understanding of the City's budget and fiscal issues
- Provide input on community priorities and develop recommendations on programs and fiscal strategies
- Make recommendations to enhance public understanding of the City budget and provide input into the budget development process
- Make recommendations to re-allocate the funding deducted from the Police budget
- Make recommendations to help achieve a long-term, sustainable budget through reducing expenditures and/or increasing revenues

Process Overview

Budget Task Force met between October 2020 and March 2021

Budget Task Force presented their top recommendations to the City Council on March 22, 2021

City Council provided feedback and gave staff direction to review the recommendations

Staff presented the proposed funding allocations and received feedback from the City Council on April 26, 2021

City Council approved resource allocations for funded recommendations on June 28, 2021 as part of the 2021-23 budget adoption

An update was presented to the Finance Committee in November 2021



Ambassadors - Pilot	175,000	Safety Ambassadors are in operation
Grant Writer - Pilot	36,000	A consultant is engaged to assist with grant writing and funding advocacy
Mental Health Services/Alternatives to Policing	500,000	Staff and the Alameda County Fire Department are working to implement the program
Navigation Center - Short term	1,600,000	Funds are committed as local match for the City's Project Homekey application pending State decision
Police Oversight	350,000	An ordinance for the creation of a Community Police Review Board (CPRB) and an Independent Police Auditor (IPA) has been approved by the City Council. The IPA contract was approved by the Council in July 2022.
Resiliency	90,000	Commenced implementation of the Climate Action Plan - process is ongoing

Community Engagement and Outreach - Budget Development	-	Implementation is ongoing
Performance Measures	-	Performance measures will be incorporated into the upcoming 2023-25 biennial budget
