# AMENDMENT NO. 1 TO CONSULTING SERVICES AGREEMENT BETWEEN THE CITY OF SAN LEANDRO AND KRISCH & COMPANY FOR

FINANCE AND ACCOUNTING MANAGERIAL SERVICES

This Amendment No.1 ("Amendment") is made by and between the City of San Leandro ("City") and Krisch & Company ("Consultant") (together sometimes referred to as the "Parties") as of October 22, 2024, and amends that certain Consulting Services Agreement ("Agreement") dated July 16, 2024, between the Parties.

**WHEREAS**, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to financial accounting and managerial services; and

**WHEREAS**, the Parties desire to amend the Agreement to March 31, 2025.

**WHEREAS**, the CSA Amendment No. 1 was approved by the Council on October 21,2024 per Council Resolution Number **XXXX**.

**NOW THEREFORE**, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

- 1. Section 1.1 of the Agreement entitled "Term of Services" is hereby amended to extend the term from October 22, 2024, to March 31, 2025; and
- 2. Section 2 of the Agreement entitled "Compensation" is hereby amended to pay Consultant a sum not to exceed \$155,000; and
  - 3. Exhibit A of the Agreement entitled "Scope of Services" is hereby amended to read:
- 4. Exhibit B of the Agreement entitled "Compensation Schedule & Reimbursable Expenses" is hereby amended to read:
  - 5. All other terms shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
