4.A. City-Wide Updates

The City of San Leandro's budget discussions continued with two Community Forums for residents to stay informed and participate in the process. Budget Engagement Forums were held on March 16th and March 17th. These forums were an opportunity to learn more, ask questions, and share input before Fiscal Year 2027, which starts on July 1, 2026.

Regarding the vacant senior commission seat for District 5, the City Clerk's Office is still accepting applications.

4.B. Human Services Department-Wide Updates

The department is launching the rental assistance program in collaboration with Bay Area Community Services (BACS). Community engagement and

outreach have been conducted to identify eligible participants. The program is scheduled to officially launch on April 1, 2026.

4.C. Senior Services Updates

Naranjo highlighted some recent senior services since the last Senior Commission meeting, including a veteran information session, CA Highway Patrol Age-well workshop, Alzheimer and Dementia workshop, and senior day trips.

Regarding upcoming services and events, informational sessions for Fresh Approach's Market Match and Voucher program will be held, and additional Alzheimer and Dementia workshops.
