

**AMENDMENT NO. 1 TO CONSULTING SERVICES AGREEMENT BETWEEN
THE CITY OF SAN LEANDRO AND
DIXON RESOURCES UNLIMITED**

This **Amendment No. 1** (“Amendment”) is made by and between the City of San Leandro (“City”) and Dixon Resources Unlimited (“Consultant”) (together sometimes referred to as the “Parties”) as of August ___ 2018, and amends that certain Consulting Services Agreement (“Agreement”) dated August 1, 2017, between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to parking management services; and

WHEREAS, the Parties desire to amend the Agreement to extend the service time for one year for a value of \$90,000.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

1. Exhibit A of the Agreement entitled “Scope of Services” is hereby amended to read:

**EXHIBIT A
SCOPE OF SERVICES**

Dixon Resources Unlimited will support the City of San Leandro and the Ongoing Implementation of the Downtown Parking Strategy. Our services include continued ongoing support as follows:

- Ensure vendor equipment is performing as promised and that the systems are accountable, well maintained, and are reconciled as required.
 - Ensure that operational initiatives are focused on improving customer services and the overall functionality of the parking system.
 - Ongoing assessment of the parking program including enforcement, maintenance, collection, and parking revenue reconciliation.
 - Monthly performance summary report.
2. Exhibit B of the Agreement entitled “Compensation Schedule & Reimbursable Expenses” is hereby amended to read:

**EXHIBIT B
COMPENSATION SCHEDULE & REIMBURSABLE EXPENSES**

San Leandro – Additional Support	
Fixed Flat Monthly Fee	\$7,500
Project Total – 12 Month Term	\$90,000
