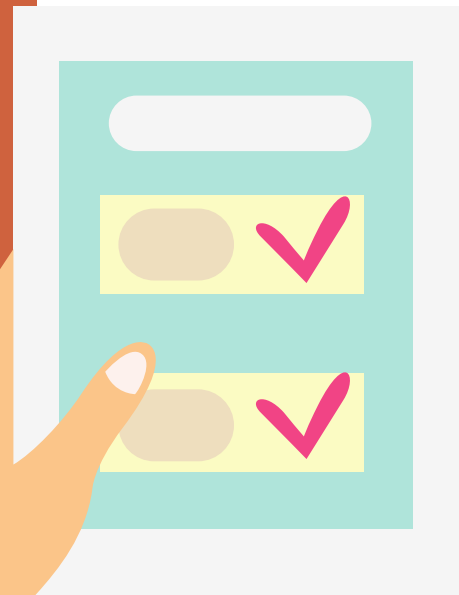

- Ask for Nominations
 - Majority (4) wins Immediate Nomination

List Randomizer

There were 4 items in your list. Here they are in random order:

1. Donald Duck
2. Mickey Mouse
3. Snoopy
4. Woodstock

- Council Discussion on Nominees
- Clerk uses random list generator to create voting order
- Each nomination added to list
- Vote taken in random order
- First Nominee to reach 4 Yes Votes Wins Appointment
