To be eligible for appointment to a board or commission, one must be a registered voter (except Youth Advisory Commissioners) and must reside in the City of San Leandro and in the district in which the vacancy occurs. No member of any board or commission shall be a member of any other board or commission or hold any paid office or employment in the City Government (San Leandro Municipal Code §1-3-125).
