AMENDMENT NO. 1 TO CONSULTING SERVICES AGREEMENT BETWEEN THE CITY OF SAN LEANDRO AND LAZ PARKING FOR PARKING ENFORCEMENT SERVICES

This **Amendment No**.1 ("Amendment") is made by and between the City of San Leandro ("City") and LAZ Parking ("Consultant") (together sometimes referred to as the "Parties") as of July 1, 2025, and amends that certain Consulting Services Agreement ("Agreement") dated August 1, 2022, between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to parking enforcement, and

WHEREAS, the Parties desire to amend the Agreement to extend it two years to end on June 30, 2027, and

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

- 1. Section 1.1 of the Agreement entitled "Term of Services" is hereby amended to extend the term from July 1, 2025, to June 30, 2027; and
- 2. Section 2 of the Agreement entitled "Compensation" is hereby amended to pay Consultant a sum not to exceed \$1,006,140 for Parking Enforcement Services and Meter Repair and Maintenance Services to be provided from July 1, 2025 through June 30, 2027; and
- 3. Exhibit A of the Agreement entitled "Scope of Services" is hereby amended as detailed in Attachment 1 to this Amendment titled LAZ's Proposal for Parking Enforcement Extension of Services dated April 21, 2025; and
- 4. Exhibit B of the Agreement entitled "Compensation Schedule & Reimbursable Expenses" is hereby amended as detailed in Attachment 1 to this Amendment; and
- 5. Except as modified by this Amendment, all other terms shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
