Introduction

The City of San Leandro utilizes volunteer boards and commissions to gather and analyze public input on various subjects and make recommendations to the City Council.

Each board or commission is assigned a staff person who serves as its secretary. Secretaries collect and forward attendance data to the City Clerk's Office. The data is compiled into an annual report for review by the City Council.

About the report

Attendance policy

The City Council Member Handbook establishes the meeting attendance policy for members of boards and commissions:

- 1. Members of boards or commissions shall be required to attend not less than 75% of all regular meetings held;
- 2. Failure by a member to attend three consecutive regular meetings of a board or commission will be cause for Council declaring the member's position vacant;
- 3. Attendance records will be reviewed by the City Council once a year based on the previous 12-month period, except for appointments effective July 1st or thereafter. ¹

If a member is unable to attend a meeting, the secretary or chairperson must be notified before the meeting.²

Report parameters

This report covers the period of May 2023 to April 2024. Only regular meetings are included.

Figure 1 – Example attendance

In the example shown above, Jane Doe serves on the Senior Commission.

- Five regular meetings were held in the reporting period
- Jane served on the commission for three of the meetings
- Of those three, she was present for two meetings and absent from one

Therefore, Jane's percent of regular meetings attended is 67% (or 2÷3).

Because her attendance has fallen below the required 75%, the % Attendance column is highlighted in orange.
