Elias Sorokin, 29, vanished during a business trip to Northern California.....***Detectives believe Sorokin was kidnapped and robbed in the course of a pre-arranged marijuana transaction at a residence in Santa Cruz.*** Police are treating the case as a homicide investigation. Santa Cruz police arrested Stewart Skuba and Kenneth Klamp, each 29-year-old Santa Cruz residents. Skuba is being charged with kidnapping with the intent to commit robbery. Clamp is currently being charged with a parole violation. Hunt is also charged with kidnapping with the intent to commit robbery.....They have announced a \$20,000 no-questions-asked reward for information leading to Sorokin's safe return.

Sheriff's deputies say Los Osos fatal shooting was robbery gone wrong

San Luis Obispo County Sheriff's Deputies say a botched robbery attempt is to blame for a deadly shooting in Los Osos. The incident happened around 7:30 p.m. Saturday at a home on the 1900 block of 12th Street.***The shooting left one man dead in the street and another injured inside the house. "It appears to be a home invasion robbery in which marijuana was the focus,"*** said Rob Bryn, spokesman for the San Luis Obispo County Sheriff's Department. At this time deputies are not naming any suspects, but Orlauski says her neighbor pulled the trigger.Orlauski and other neighbors, who did not want to talk on camera, say the marijuana grow is legal, but deputies say otherwise. People living in the area also tell KSBY News Saturday night's robbery attempt was not the first. "He knew people were trying to steal from him, and they'd even called him on the phone and taunted him and been like, 'We're going to come back, and we're going to steal more from you,'" said Orlauski.Investigators say the second shooting victim was transferred out of the county to undergo surgery for non-life threatening injuries.

Slow going in search for possible bodies

A tedious excavation is under way in the hills above Hiouchi, as investigators continue their search for the bodies of potential murder victims.Authorities became aware of the possibility that people were buried in Earth People's Park after a ***woman who lived there told a Del Norte County deputy district attorney that she saw a man she was with shoot another man in the face while tied to a tree.***Earth People's Park is a privately owned tract of land surrounded by U.S. Forest Service and Redwood National and State Parks property. It is known as a communal living area, and when authorities arrived Monday they found abandoned tents, empty sleeping bags, a dilapidated, two-story building and about 400 marijuana plants in various stages of growth. According to a search warrant, the woman who purportedly saw the murder said she heard the gunman yelling at the unidentified victim about marijuana before he shot him.

Once the victim is in the van, Martinez gets argumentative and combative and demanded the return of his marijuana. The victim denied that he stole or had the defendant's marijuana and demanded to be let out. Martinez refused to stop the van. Martinez fired one shot into the van in victim's direction. Victim again denied any knowledge about the defendant's marijuana. Faced with further hostility from Martinez, the victim attempted to escape through the back window. As the victim was trying to leave the moving van, Martinez fired several more shots, hitting the victim who was later located on the roadside.

Man shot after botched marijuana theft attempt in Concord

CONCORD — A man shot outside a house on Kauri Court was part of a group attempting to steal marijuana from a legal garden, police said Monday. Three residents of the home on the short street heard a security alarm about 4:45 a.m. Sunday and saw a man in their backyard stealing marijuana plants, Concord police Lt. Jim Lardieri said. The residents went outside and were able to overpower the man and then heard other men yelling for them to release him. The residents felt threatened, police said, so they let go of the man, who then got into a waiting pickup truck, which drove away. They told investigators they then heard a gunshot. The residents or neighbors called police, who responded as the truck was leaving and arrested all six people in the vehicle. One had been shot in the lower leg but his injury wasn't serious, police said. He was treated at a hospital. All of the suspects were arrested on suspicion of conspiracy to commit a crime.....A handgun was recovered near the intersection of Joan Avenue and Cape Cod Way. Investigators believe that the man who was injured was shot by someone inside the pickup truck, and the gun was thrown from the vehicle.....

Four arrested after robbery during pot deal

Police arrested four Redwood City men after a marijuana transaction ended in an armed robbery and traffic accident in the city Wednesday afternoon. At about 1:20 p.m., a 27-year-old man negotiated with Carlos Sanchez Martinez, 36, police said. The 27-year-old, Adalid Sanchez Soto, agreed to sell Martinez 50 pounds of high-grade marijuana for \$70,000, according to police. The two men met at an apartment in unincorporated Redwood City, and when Sanchez delivered the marijuana, he was robbed at gunpoint by Martinez and two other suspects, police said. The suspects tied the victim up and left him in the apartment while they loaded the marijuana into a vehicle and left, according to police. However, shortly afterward the suspects abandoned their vehicle and left the area while leaving the marijuana in the vehicle, police said. The driver of the vehicle that collided with the suspect vehicle was transported to a local hospital with minor injuries.....

Pot shops sprouting — and so are robberies

CRIME: Valley's 100 medical marijuana dispensaries called vulnerable to bandits, burglars.

.....***There have been at least 200 robberies at medical marijuana dispensaries in the Valley in the last two years*** -- or an average of two for each of the Valley's estimated 100 facilities, according to Los Angeles police. They say the nature of the business -- dealing in drugs and cash -- makes them prime targets for thieves. The most recent stickup occurred about 10 p.m. Wednesday, when masked gunmen tied up employees at a Canoga Park clinic and made off with an undisclosed amount of money and marijuana. The disturbing trend exposes the vulnerability of the businesses, where thieves can potentially snag tens of thousands of dollars and pounds of drugs. "It certainly is a phenomenon that has happened with the proliferation of these dispensaries," said LAPD Deputy Chief Michel Moore, the top-ranking officer in the San Fernando Valley. "***They are easy targets.***"***This is an absolute disgrace and a mockery of law. It's not about compassion. These people have turned it into a moneymaking enterprise. They could care less about compassion.***" Zine's concerns echo those voiced by police -- that the dispensaries are simply selling marijuana to anyone rather than distributing it to members with health problems.....Deputy Chief Moore believes some dispensaries haven't reported problems, so the

number of heists may actually be higher than 200. "On the basis of the information that I have, these locations are an attractive site for suspects to either commit burglary or robbery," Moore said. "They're going to get narcotics, and they're going to get money.....Three gunmen and a woman got away with cash and marijuana in a Wednesday night takeover robbery of a dispensary in the 22300 block of Sherman Way. Authorities are investigating whether any of those robbers may have been involved in a string of heists that began in the West Valley in late May. Suspects in those stickups pistol-whipped employees at one dispensary and shot a man in the back at another.....

A Los Angeles kidnapping investigation led police Monday night to a spacious Eastvale home where authorities say they uncovered a sophisticated drug operation. A SWAT team stormed the building, rescued the hostage and arrested the man renting the Delaware River Drive house on suspicion of kidnapping.....A ransom had been demanded, she said. The victim had been shot in the stomach police believe it happened when he was abducted from his Van Nuys home Wednesday.....The LAPD officers noticed an advanced marijuana-growing operation when they entered the 4,200-square-foot house and called Riverside County sheriff's investigators.....The home was equipped with an additional air conditioning unit and illegally tapped into a power supply, authorities said. The marijuana operation had been under way for at least a year and had the capability of producing about \$50,000 worth of marijuana every few months, Riverside County Sheriff's Sgt. Dennis Gutierrez said. Neighbors in the quiet Eastvale neighborhood said they suspected something was amiss. Art Organisto, 46, said that for the past six months he would regularly see rental trucks arrive at the home and see men running brown packages out to them.....

West Oakland home robbery leads to large marijuana bust

Police: Man arrested with \$1,600 worth of pot

The Lake Forest man said he bought it at a medical marijuana dispensary in the city.

LAKE FOREST – Police on Monday night arrested a man who said he had recently purchased marijuana at a Lake Forest medical marijuana dispensary. At 11:45 p.m., an Orange County Sheriff deputy pulled over a motorist who rolled through a stop sign near Ridge Route Road and Rockfield Boulevard, driving 30 mph. Upon stopping the vehicle and speaking with the driver, identified as David Dunlap of Lake Forest, the deputy detected a strong smell of marijuana. He found 1 gram of marijuana on Dunlap and an additional 97 grams along with zip lock plastic baggies and a scale inside Dunlap's backpack, said Sheriff's Lt. Don Barnes. *Dunlap told the officer that he had purchased the marijuana from a Lake Forest dispensary. Upon further investigation, the deputy determined that Dunlap also had once been employed by a Lake Forest dispensary. "He had a medical marijuana card but is now selling it on his own,"* said Barnes. "His arrest interrupted several pending sales." Dunlap told the deputy that he only sells to people with medical marijuana cards. "He was clearly operating outside the provisions of the Compassionate Use Act," said Barnes.....

It's the beginning of harvest season — and that means a seasonal increase in theft of medical marijuana plants. In the last four days alone, three incidents were reported to the Nevada County Sheriff's Office. "It's that time of the year," said sheriff's Capt. Jeff Powell. "Between now and the end of October, the plants are maturing and it's getting time to steal them because the buds are getting big — they have the THC in them. "I think this year, we're seeing quite a few more (thefts)," he continued. "A lot more people are growing medical marijuana nowadays. They're able to get more scrips, so they feel more comfortable." Tuesday night, a man from Rocker Road reported youths stole medical marijuana plants over the weekend. He saw them trying to steal more plants and confronted them. He told a dispatcher he did not want to pursue criminal charges, however, and would look into a restraining order. A woman from Kangaroo Court reported the theft of six marijuana plants while she was home, sometime between midnight and 6 a.m. Tuesday. The homeowner, who wanted to remain anonymous due to security concerns, said the plants belonged to her sister, who has a medical marijuana prescription for fibromyalgia. The woman said the plants were in a fenced and tarped garden, but were visible from the street. "Somebody had been watching," she said. "They cut a hole in the fence." The woman believed her sister scared the culprits off when she got up at 3 a.m. and turned on some lights. They left behind part of the plants, as well as a crowbar and a tire iron. "I'm sure they were anticipating using them on a dog," the woman said of the abandoned tools. The victim said the plants weren't even mature yet and the theft means her sister will have to purchase marijuana from a dispensary, at a cost of approximately \$400 a month. "We're afraid to leave the house," she said. "We're afraid they might come back and try to see if we have any inside. It's kind of scary." Friday at 1 a.m., a man from Orchard Springs Road reported someone broke into his shop and took several marijuana plants. Several of his friends detained a suspect in the parking lot of a nearby store. "They couldn't link that person to the theft, so he was released," Powell said. "The deputy went back to the victim's house to take down his information and found a vehicle with two people in it who admitted to stealing marijuana from someone's garden. They had cutting tools in their possession.".....The victim estimated the loss at about \$10,000, he said. Powell had some advice for county residents growing medical marijuana. "Don't advertise that you're growing," he said. "Keep the information to yourself." And if you hear someone in your garden in the middle of the night, he added, "Don't confront them. That's number one." Powell noted there have been violent incidents in the past, including shootings last year. "We've had none so far this year, knock on wood," he said. "You have a right to defend your property, but you don't know who's out there."

La Brea Fire believed to be caused by \$90 mil. marijuana operation run by Mexican drug cartel

The Santa Barbara County Sheriff's Department releases more details on their investigation into the start of the La Brea Fire burning east of Santa Maria. At a press conference Tuesday, sheriff's investigators said they believe the La Brea Fire was started by a cooking fire used by people running an illegal marijuana operation in a remote area of the Los Padres National Forest. A propane stove was found in their camp at the origin of the fire. Sheriff's investigators believe there were five or six people tending the marijuana farm, and that some of them may still be trying to leave the forest on foot. They say an AK-47 assault rifle was found in the camp, so the suspects should be considered armed and dangerous. The marijuana farm found near the origin of the fire contained about 30,000 plants with an estimated street value of about \$90 million. Sheriff Bill Brown said this has been one of the busiest seasons of marijuana eradication in Santa Barbara County's history, with 18 farms eradicated since April 18, 2009 - a total estimated street value of \$675 million.....

Deputies find large pot garden, encounter armed suspects

LAKE COUNTY – On Tuesday local and federal law enforcement officials eradicated a massive illegal marijuana garden in the Mendocino National Forest, encountering armed suspects in the process. The Lake County Sheriff's SWAT Team and detectives from the US Forest Service seized approximately 130,000 plants and five firearms – including a Tec 9 assault weapon with a makeshift silencer – according to sheriff's Capt. Rob Howe. . . . Howe said this is the third marijuana cultivation operation so far this year in which sheriff's deputies have encountered armed suspects. Howe noted, "We are very grateful these suspects have not pointed their weapons or fired at our personnel." Concerns over dangers about illegal marijuana growing operations on public and private lands led Sheriff Rod Mitchell to post a public safety message late last week on his Web site. The video explains that violence in connection with marijuana growing is increasing. Last September, the county saw the first murder associated with a growing operation. In that case, the body of a Santa Rosa man was found in an illegal grow on Socrates Mine Road, where he had been shot to death, as Lake County News has reported. The sheriff's office reported that 2009 is "already surpassing last year in seizures and violence." While eradicating a grow on Socrates Mine Road in June, deputies encountered two armed suspects who fled and evaded capture, according to the report. In addition to locating firearms and armed growers, deputies have discovered booby traps, such as a rat trap outfitted with a shotgun shell, which they recreated and shot through a human-shaped target. They've also found rat and mouse poison, litter and other environmental concerns in the grows. Nearly all of the illegal grows are discovered and eradicated through the use of helicopters, which the county rents from private companies and pays for through a \$275,000 Drug Enforcement Administration Grant. Tuesday's raid brings this year's total for eradications to more than 285,000 plants and 15 arrests, based on various sheriff's reports. That puts Lake County – which in recent years has led all of California's 58 counties in eradications of illegal marijuana – close to Mendocino County, which so far this year has netted close to **280,000 plants, made close to 60 arrests and seized around 50 firearms at more than 90 sites.**

Sheriff's deputies in Fresno County are continuing a marijuana plant eradication program, raiding several illegal outdoor gardens (including sites erected in state and national parks) and netting tens of thousands of pot plants. . . . A single plant may produce \$4,000 worth of marijuana. A report by the National Drug Intelligence Center says California's Central Valley is one of the most significant cultivation areas for cannabis in the country. In 2008 authorities eradicated more than 5.3 million cannabis plants (both indoor- and outdoor-grown) in the state, according to the Drug Enforcement Administration (DEA), and about one-quarter of those were in the Central Valley. Data also shows that outdoor cultivation has been on the rise over the past five years in Fresno, Kern, Shasta and Tulare Counties. During a raid near Balch Camp, Calif., Lt. Bob Miller of the Fresno County Sheriff's Department told CBS affiliate KGPE that illegal growers cut down and cleared out trees and hauled in fertilizers, drip lines and other equipment. "Extremely, extremely sophisticated operations," he said.
The eradication of the illegal gardens is not just to keep drugs off the streets but also to prevent

environmental damage: Highly-toxic chemicals from the growing sites - from pesticides and chemical repellents to rat poison - pollute watersheds, harming fish and wildlife and eventually getting into the water supply. The Fresno Bee reports that at one encampment in the foothills of the eastern part of Fresno County, approximately 10,000 plants were growing in a one-third acre patch. A shelter with kitchen and canned supplies were also found. Forest Service volunteers will help clear out trash from the encampments. Also this week, authorities removed about 3,500 marijuana plants found growing in park land in the Santa Monica Mountains. The National Park Service said Wednesday that trash, pipes, camping equipment, fertilizer and pesticides were also removed Tuesday from three plantations - two located in Malibu Creek State Park and one in the Zuma-Trancas Canyon area. (CNN) -- Authorities have seized \$1 billion worth of marijuana plants and have arrested 82 Mexican nationals with ties to drug cartels in the first week and half of an effort to eradicate marijuana fields from California's Fresno County, the county sheriff's office said Wednesday. The 82 suspects arrested so far have links to Mexican drug cartels..... Eastern Fresno County, where the seizures have been made, is mountainous and sparsely populated. Growers exploit the area's streams, rivers and lakes to create elaborate drip lines for their plants. A mature plant can be worth \$4,000, said Fresno County Sheriff Margaret Mims. "Fresno County is roughly the size of Connecticut, and the drug traffickers target these areas because they know there is not that significant of a law-enforcement presence," Mims said. "The chances of getting caught are slim." "The bottom line is our public lands are being destroyed by foreign drug trafficking and heavily armed Mexican cartels," George Anderson of the U.S. Department of Justice said Wednesday at a news conference highlighting the seizures. The operation is the largest in Fresno County history and one of the largest in California, Mims said. "What makes this operation unique is the approach: prevention, enforcement, eradication and reclamation," she said. Intelligence gathered for the operation began in February, with community presentations about prevention. The effort is now focused on shutting down the at least 70 marijuana farms identified by local authorities. The operation is expected to continue into November, when colder weather makes marijuana growing more difficult. At least 330,000 marijuana plants have been seized.....

One of the hikers was hit in the face with what looks to be shotgun pellets,* authorities report. Deputies from the Porterville substation as well as resident deputies responded to the area and found the hikers. Medical personnel treated the shooting victim and transported him to Sierra View District Hospital, where he was later released. Deputies from specialized units of the Sheriff's Department found a trail leading to the grow site and searched the area. They were not able to find the suspects. They did find four grow sites and ultimately destroyed more than 10,000 marijuana plants. If allowed to mature, authorities said the marijuana would have had a street value of \$40 million. Authorities report extensive damage at the grow sites. Those growing the marijuana used liquid fertilizers and altered natural water courses to water and fertilize the illegal plants. The native vegetation was clear-cut, and the mountainous terrain was terraced to allow for water storage reservoirs. Trash was also found in the area. The grow sites comprised more than 10 acres of public lands. The cost of restoring land damaged by illegal marijuana groves is approximately \$11,000 per acre, the Sheriff's Department reports.....

Major marijuana eradication in Merced County

About a dozen officers consisting of Merced Sheriff's Deputies and MMHIDTA Agents along with the Sheriff's helicopter, working off a Federal Grant, hit three locations where marijuana grows were spotted. The first location on Arburua Road inside a canyon had an irrigation drip system that went on for miles to bring water to the plants. There were two more locations, one on Wolfsen Road and one on Washington Road that were hit early Saturday morning. In all, 35,500 plants were seized. According to Sergeant Steve Sziraki some of the plants ranged anywhere from four to twelve feet in height. Officers in Merced County seize about 35,000 marijuana plants at three separate locations this weekend. With that many plants in different phases of growth, and at a street value the team eradicated over \$50,000,000 worth of marijuana. The teams came across sophisticated encampments where suspects would stay for days on end to tend to their gardens. They also found approximately 15 to 20 lbs of trimmed "bud" that the suspects had already harvested from the plants.

U.S. Forests Become Toxic Marijuana Plantations

Phil Taylor reports for the New York Times that Mexican drug cartels have taken over state and federal park land to cultivate marijuana fields which are destroying the environment: "Mexican drug trafficking organizations have been operating on public lands to cultivate marijuana, with serious consequences for the environment and public safety," said Gil Kerlikowske, chief of the White House's Office of National Drug Control Policy. * * * The drug plantations are as much an environmental menace as they are a public safety threat. Growers in Fresno County used a cocktail of pesticides and fertilizers many times stronger than what is used on residential lawns to cultivate their crop. "This stuff leaches out pretty quickly," said Shane Krogen, executive director of the High Sierra Volunteer Trail Crew in charge of helping clear the land of chemicals and trash so it can begin its slow restoration. While the chemical

pesticides kill insects and other organisms directly, fertilizer runoff contaminates local waterways and aids in the growth of algae and weeds. The vegetation in turn impedes water flows that are critical to frogs, toads and salamanders in the Kings and San Joaquin rivers, Krogen said. * * * Bankrolled by sophisticated drug cartels, suppliers are sidestepping border patrols to grow in relative obscurity on Forest Service, Bureau of Land Management and National Park Service lands across the West and even into the Southeast. "It's easier to cross the border to grow marijuana on public lands than to grow it in Mexico and smuggle it across," Krogen said. * * * "There is a growing issue of marijuana cultivation on public lands in the U.S., especially in California and Oregon, and it appears they have discovered southwestern Idaho," said BLM special agent in charge Loren Good. Temperate climates on the West Coast have nurtured what has become a booming marijuana market. * * * "It's definitely a trend," said Keith McGrath, a law enforcement officer in BLM's Idaho office who was part of last month's raid in a far-flung desert canyon. "We're seeing a shift to more organized grows and larger grows," McGrath said. "They're being set up and run through the cartels, and it's becoming a big chunk of our work load."

Deputies Eradicate \$26M In Marijuana

Deputies executed a search warrant on BLM property near Erskine Creek, which is approximately seven miles southwest of Lake Isabella. Deputies and Agents located and eradicated approximately 4100 Marijuana plants, the KCSD reported. The grow appeared to have been abandoned and many of the plants were dying or were dead from lack of water. Deputies located a separate Marijuana garden approximately one mile away. They served a separate search warrant for this garden, the KCSD reported. Deputies located and eradicated 2406 Marijuana plants, the KCSD reported. The plants were healthy and appeared to be freshly watered. Deputies followed a water line from the garden. The water line which was partially buried, led to a residential property approximately a half mile away, the KCSD reported. The property had a small residential camper, water tanks, and other storage campers and sheds on it. Deputies obtained and served a search warrant for the property, the KCSD reported. Deputies located several pounds of processed Marijuana, waterline, fertilizer, two Marijuana plants, and six rifles on the property, the KCSD reported. The owner of the property could not be located initially. This investigation is continuing. The estimated value of the seized Marijuana is \$26,000,000.

PALO ALTO, Calif.—Law enforcement officers have seized about \$60 million worth of marijuana in a raid that took out two large pot gardens in the Palo Alto hills. The Santa Clara County Sheriff's Department worked with other agencies in Wednesday's bust, which netted about 20,000 marijuana plants. No arrests were made, but the officers also discovered some ammunition, a Taser-type weapon and some evidence of poaching. They could hear rain falling through the trees. Crouched with their guns drawn, the SWAT members remained absolutely still until the helicopter roared overhead. Suddenly there was an explosion of movement and a running blur of camouflaged shadows as officers stormed a large marijuana plantation owned by the Mexican mob. When the confusion died, law enforcement began seizing and destroying more than 23,000 marijuana plants which, combined with another 25,600 plants found later, equaled the largest plantation in Amador County's history.....Officers also began to calculate the plantation's devastating impact on the terrain, which was located near one of the most pristine areas of the Eldorado National Forest. Various sections of trees had been clear-cut. An entire section of the mountainside had been terraced away and riddled with makeshift watering systems. Thousands of plastic nursery cups were piled high in the vegetation. Closer to the encampment, which looks to have housed five people, the growers ripped gaping holes in the soil and filled them with trash, fertilizer and other toxic chemicals.....Due to the extreme violence of these cartels - which has included the murder of Mexican law enforcement personnel, jury members, eyewitnesses and reporters - the White House has classified them as "terrorists." The immediate danger to California citizens from the cartels has grown in the last decade. In 2000, a father and his 8-year-old son were both shot after stumbling onto a marijuana plantation in El Dorado County during a hunting trip. Though wounded, they survived the encounter. In February 2008, a Santa Rosa man was murdered by cartel growers after entering a plantation in the southern part of Lake County. June 2009 saw growers in Lassen County open fire on law enforcement, wounding two sheriff's deputies and leading to one grower being killed in the exchange. "There have been plenty of shootings related to these operations now," Long said. "There's no doubt they can be violent.".....

39,115 plants were pulled from the Rainbow Ridge area, but four suspects elude capture

Late in the afternoon a Mount Shasta police officer saw two men dressed in camouflage clothing, which he described as extremely dirty, walking along a road just west of the city of Mount Shasta near Interstate 5, the release said. When the officer turned around to contact the two men, they ran into the woods. Officers from Mount Shasta police, California Highway Patrol, the U.S. Forest Service and the sheriff's department searched the area but couldn't find the two men. The highway patrol brought a helicopter from Redding to search from the air. In the news release, Sgt. Mike Gilley, who heads the Siskiyou County Sheriff's Department Marijuana Eradication Unit, reminded people that the start of hunting season coincides with Northern California's peak marijuana harvest season, a dangerous time when marijuana growers have the most to lose. Sophisticated marijuana gardens on public lands, could pose a threat to hunters, hikers or anyone who accidentally walks into a site, he said. Gilley advised people to be aware of their surroundings and to avoid areas where they see suspicious activity such as gardening supplies, hoses or PVC pipe, camouflage netting, or isolated camps in the woods. Anyone who finds evidence of a marijuana patch should immediately leave the area and contact law enforcement.

The hills of Kern County have been alive with the sound of marijuana cultivation. The air space above the hills has also been alive with the sound of helicopters looking for the green leafy plants. That has led to a record seizure of plants this year, Kern County sheriff's officials have said. And the season won't be over until later next month. At least some of the gardens removed this year have been financed by Mexico drug interests, sheriff's spokesman Michael Whorf said. Plant seizures have increased from about 21,000 plants in 2004 to about 169,000 plants this year, reported Sgt. Mike Bonsness of the sheriff's major violator unit. The value of this year's haul has been pegged at \$676 million. That's at the rate of \$4,000 a plant, which is what deputies believe is the wholesale price of a pound of marijuana. The number of plants seized more than tripled in 2007 from the year before. They increased even more in the last two years. Deputies aren't sure if that means more people are growing the plants in Kern County, or they are just catching more, Whorf said. They are catching more because they are getting more grant money to finance the time and effort into looking, he said. He said he didn't know how much grant money is used for these projects. While Kern County is finding more marijuana plants, it's significantly behind the leading marijuana growing counties in the state. Lake County found about 500,000 plants in 2007 and 2008. Tulare and Shasta counties seized nearly 400,000 plants, while Mendocino and Humboldt uprooted well over 200,000 in one or both of the last two years. Such seizures are part of a state CAMP (Campaign Against Marijuana Planting) operation that began in 1983. Those who operate the gardens typically tap into spring water to irrigate their crop. They are generally well armed and guard the plants, although they have planned escape routes if needed, officers say. So far this year, Kern County authorities have arrested 25 suspects and seized 25 firearms.

Mendocino County officials arrest 38 in pot raids

UKIAH, Calif.—Mendocino County authorities say they've arrested 38 people and seized thousands of marijuana plants in a series of raids on marijuana gardens. Mendocino County Sheriff Tom Allman says law enforcement officials found more than 53,000 marijuana plants, 30 pounds of hashish and more than \$25,000 in cash last week in searches near the communities of Laytonville and Covelo. "While they are in prison we feed and cloth them and meet all their essential needs. When they're deported they return home, turn right around and return to the U.S. in a very short period of time to start the cycle all over again. They really know the system." Asked if he thinks TNT is making a difference, he states, "Yes I do. If we were not in existence all that marijuana would be sold on the streets and the profits would be used to finance the Cartel's super methamphetamine labs in Mexico. I don't know what kind of a budget they have but anybody has to be hurting a little bit if they lose as much as they have lost in our county this year."

The driver, Kwong Wing Cheng, 50, of El Cerrito consented to a car search, and CHP officers found about 100 immature marijuana plants and a paper bag filled with \$27,330 in assorted bills. Marijuana ingredients make acute pain worse

University of Texas Medical Branch at Galveston researchers have been exploring pain. Questions about why some pain persists, while other types of pain can vanish quickly, led the scientist to explore the endocannabinoid system in the human body and how the pain response works. Endocannabinoids in the human body are closely related to compounds found in marijuana – cannabinoids. The researchers explain how systems in the spinal cord balance signals that reach the brain. Study authors Professor Volker Neugebauer, and colleagues say, "Excitatory systems act like a car's accelerator, and inhibitory ones act like the brakes. What we found is that in the spinal cord endocannabinoids can disable the

brakes." The researchers used the spinal cords of mice to determine the inhibitory effect of endocannabinoids on pain. They found that after applying a biochemical that mimics an endocannabinoid to nerve cells, there was a response to pain. When they studied the spinal cord of mice that lacked receptors for endocannabinoids, they found the pain response was blocked. "The next step was to make the leap from spinal slices to test whether this really had anything to do with pain," Neugebauer said. The researchers induced pain akin to an intense toothache in anesthetized rats, using capsaicin, found in hot peppers. They were able to measure signals racing up the spinal cords of the mice. The mice became more sensitive to pain. Blocking endocannabinoids made the pain response disappear.....Persistent pain is notoriously difficult to treat, and this study offers insight into new mechanisms and possibly a new target in the spinal cord." Endocannabinoids and cannabinoids in marijuana are biochemically similar. "If you had a toothache, you probably wouldn't want to treat it with marijuana, because you could actually make it worse. Now, for more pathological conditions like neuropathic pain, where the problem is a dysfunction within the nerves themselves and a subsequent disturbance throughout the nervous system that's not confined to the pain system, marijuana may be beneficial. There are studies that seem to show that. But our model shows cannabinoids over-activating the pain system, and it just doesn't seem like a good idea to further increase this effect", says Neugebauer. Cannabis smokers have a seven-fold schizophrenia risk

WINNIPEG – The Harper government is putting up \$550,000 to gather research on marijuana use and mental illness. The Schizophrenia Society of Canada will use the money to further research the links between cannabis and early psychosis as well as develop promotional materials warning youth about the dangers of smoking pot. The money is part of Ottawa's \$30 million national anti-drug strategy announced in 2007. Chris Summerville, CEO of the Schizophrenia Society, said the public doesn't realize that cannabis users have a seven-fold increase in risk of developing schizophrenia. He pointed to recent research out of Victoria, B.C., linking pot smoking and mental illness. As part of the society's research, some 30 youths who have experienced psychosis will be trained to gather information about the reasons their peers use cannabis. The results will be used to develop educational materials aimed at decreasing the use of illicit drugs among young people. Winnipeg Conservative MP Joy Smith said Tuesday that while the public regards marijuana as a soft drug, there may be very serious consequences for young pot smokers who have a predisposition to mental illness. "Science has shown that cannabis may actually trigger the onset of psychosis and may also intensify the symptoms for those who already have a psychotic illness," Smith said in announcing the grant. "It has been suggested that up to 80 per cent of youth who have had a psychotic episode were using cannabis. And that's pretty shocking," said Smith, who was filling in for Health Minister Leona Aglukkaq at news conference.

[2] (11) They added: "the effects of cannabinoids on the symptoms studied are generally modest, and in most cases there are more effective medications." [3] In concluding, they stated that, at best, there is only anecdotal information on the medical benefits of smoked marijuana for some ailments, such as muscle 'spasticity'. For other ailments, such as epilepsy and glaucoma, the study found NO evidence of medical value and did not endorse further research. [4] Also, note the number of and

significance of “ailments” that were added onto each state’s qualification to use marijuana. They also explained that “smoked marijuana ... is a THC crude delivery system that also delivers harmful substances.” Also, that “plants contain a variable mixture of biologically active compounds and cannot be expected to provide a precisely defined drug effect.” The principal investigators explicitly stated that using smoked marijuana in clinical trials “should not be designed to develop it as a licensed drug, but should be a stepping stone to the development of new, safe delivery systems of cannabinoids. [5] Thus, even those scientists and researchers who believe that certain active ingredients in marijuana may have potential medicinal value openly discount the notion that smoked marijuana is or can become “medicine.” Also, note that as of May 8th, 2006, DEA had registered every one of the 163 researchers who requested to use marijuana in studies and who met Department of Health and Human Services standards. [6].....The Center for Medicinal Cannabis Research (CMCR) conducts studies "to ascertain the general medical safety and efficacy of cannabis and cannabis products and examine alternative forms of cannabis administration. [7] They Center for Medicinal Cannabis Research (CMCR) has 11 on-going studies involving marijuana and the efficacy of cannabis and related compounds as they relate to medical conditions such as HIV, cancer pain, MS, and nausea. [8] Still, however, the clear weight of the evidence is that smoked marijuana is harmful and other drugs already FDA-approved (Marinol, for example – a synthetic THC) has been proven to be safer and more effective than smoked marijuana. As stated previously: In the states where legalization has been proposed and then passed as a ballot measure / referendum, drug users presented the need for this medicine on the basis that it was needed for the terminally and seriously ill. Then, after the fact, legalization proponents added nearly every malady imaginable. Another fact that gives real insight into this situation is that a survey in California revealed that the medical marijuana cardholders had been smoking for an average of 17 years before they applied for their cards. Legalization of marijuana, no matter how it begins, will come at the expense of our children and public safety. It will create dependency and treatment issues, and open the door to use of other drugs, impaired health, delinquent behavior, and drugged drivers.

CDC: L.A. teachers ill from pot brownies

LOS ANGELES (AP) — Federal health officials say five preschool teachers in Los Angeles were sickened earlier this year after eating marijuana-laced brownies bought from a street vendor. The Centers for Disease Control and Prevention said Thursday that police investigated the April incident, which occurred at an unidentified school. A preschool teacher, who did not eat the snack but gave it her adult son, bought the brownies from a sidewalk vendor and shared them with her colleagues. Five teachers ate one brownie each. The CDC says a sixth teacher took a bite and spit it out after complaining of an "unusual taste." The teachers recovered within hours. A brownie sample tested by Los Angeles police found traces of marijuana. The teacher who bought the brownies was not charged. Police have not found the street vendor.

South Tahoe plans crack down on marijuana providers

SOUTH LAKE TAHOE, Calif. — South Lake Tahoe city attorneys Jacqueline Mittelstadt and Patrick Enright have signaled police will begin enforcement against three medical marijuana providers who have opened in South Lake Tahoe over the past year. "Possession of amounts of marijuana in excess of the allowable state law amounts is a violation of both state and federal law," the attorneys wrote in a memorandum to the City Council dated July 7. "(South Lake Tahoe police) will soon commence pursuit of such illegal conduct.".....The city attorneys refer to the Police Officer's Association White Paper in contending that most storefront dispensaries fail to meet the requirements of California law. But Cody Bass, a spokesman for Tahoe Wellness Collective, said the medical marijuana provider is operating in accordance with California law. He questioned whether the city could legally bust the collective. "South Lake Tahoe Police Department has to follow the state constitution," Bass said. "I'm personally not too worried about it." Tahoe Wellness Collective became the second medical marijuana provider in South Lake Tahoe when it opened in January in the Bijou Shopping Center, and has more than 700 patients, Bass says. If police did raid the collective, Tahoe Wellness Collective would reopen "within 20 minutes," Bass said Friday.....

Walnut Creek trying to shut down medical marijuana collective

As a medical marijuana debate swirls in Walnut Creek, leaders of the city's first dispensary — apparently operating for the past few months — refuse to shut down even as the city fines it hundreds of dollars. The C3 Collective, a nonprofit private medical marijuana collective based in Walnut Creek, can be fined \$500 per day for violating the city's zoning code, according to city officials. The violation: The collective, which the city would consider a pharmacy, is in an area zoned for office and residential, said City Attorney Paul Valle-Riestra. The city's code enforcement officer checks to see if C3 is still open. The city has cited the business three times. The fines started at \$100, then went to \$250 and have peaked at \$500 per citation. C3 is appealing the violations.....Both police and the city's code enforcement officer continue to monitor the collective, Valle-Riestra said. The city could seek an injunction to stop the dispensary operation, but has not done so. The collective has not applied for a zoning change, said Valle-Riestra. The violations are not related to the 45-day moratorium the City Council passed Aug. 18 banning medical marijuana dispensaries in the city.....

Walnut Creek sues to shut down medical marijuana dispensary

Walnut Creek sued Tuesday in Contra Costa County Superior Court to shut down the C3 Collective — the city's first medical marijuana dispensary. City leaders assert that the dispensary at 1291 Oakland Blvd., which opened in August, is operating illegally, violating Walnut Creek's zoning laws. Meanwhile, leaders of another collective said Tuesday they plan to open a dispensary in Walnut Creek. Larry Flick of Greenleaf said he plans to open a wellness center that would dispense medical marijuana and offer massage, yoga and counseling. He said he operates other centers and plans to work with the city to get a Walnut Creek center open. These latest developments follow the City Council's go-ahead Tuesday night directing city staff to study allowing or permanently prohibiting medical marijuana dispensaries in Walnut Creek. This rather procedural action drew a crowd, mainly of medical marijuana users, who pleaded with the council to allow dispensaries. City Attorney Paul Valle-Riestra said the city currently prohibits such dispensaries. In August, the City Council passed a 45-day moratorium on dispensaries after learning that C3 was operating. Shortly thereafter, staff found a zoning law that prohibits any use that violates federal law. Marijuana is illegal federally, for all purposes, so a moratorium is not even necessary, Valle-Riestra said. The city has been fining C3, a nonprofit private collective, as much as \$500 a day to get it to close. The lawsuit was the next step, Valle-Riestra said. "Clearly the citation process wasn't persuasive," he said.....

Supervisors OK 45-day moratorium on new medical marijuana dispensaries

LAKEPORT – A unanimous Board of Supervisors vote Tuesday put into effect a 45-day moratorium on the opening of new medical marijuana dispensaries, which officials said is meant to offer county staff time to complete a draft zoning amendment to deal with the establishments. Supervisors Rob Brown and Jim Comstock worked with County Counsel Anita Grant and Community Development Director Rick Coel to draft the six-page urgency ordinance. Grant noted during the meeting, “The point here is to buy you a little breathing room to ensure that you address everyone's rights under the law.” Brown said the proposal was in response to an “explosion” of collective and dispensary openings that started this spring after the board began discussing the fact that the county's zoning ordinance doesn't specifically allow for them. That had led to notices of violation on six such establishments, which the board agreed to stay. He said the board wasn't going to discuss the merits of medical marijuana or Proposition 215, the Compassionate Use Act of 1996, which allow medical use of the drug in the state. Brown said his intention was for the temporary moratorium only to affect those dispensaries and collectives which had opened after the Notices of Violation were issued in April. “Anybody who's planning on putting one in right now or is in the process of putting one in shouldn't be allowed to put it in,” said Brown. Supervisor Jeff Smith pointed to news reports about other areas dealing with similar issues. That same day, the boards of supervisors for Shasta and Tehama counties considered similar urgency ordinances to place temporary moratoriums on collective and dispensaries, with Shasta voting one down and Tehama approving their version. Rushing asked if anyone can explain why the issue is coming up so frequently. “Because there's a lot of money to be made in it,” said Brown. Smith said it's also harvest time, but he believed many jurisdictions want to get ahead of what is happening with such marijuana sales outlets. Before opening public comment, Board Chair Denise Rushing set some ground rules for the large number of people in the chambers. “I'm going to need to cut you off if you talk about the medical benefits of marijuana,” she said. “We've had plenty of that already. That's not what this is about.” She said a committee to deal with the zoning issues hasn't been formed, and that the effort is taking place all in the public eye. Lower Lake attorney Ron Green presented several suggestions to alter the resolution which he and retired District 1 Supervisors Ed Robey drafted. He said they were meant to clarify the moratorium's language. He wanted the document's third paragraph changed to note that the Lake County Zoning Ordinance does not “presently explicitly allow” dispensaries and collectives. “The reason for that is that the zoning ordinance may in fact allow for medical marijuana dispensaries under the category of similar uses that are permitted in each zoning class,” Green said. He said dispensaries are most similar to pharmacies and drug stores, as well as liquor stores. “Where does the Lake County Zoning Ordinance presently allow it anywhere?” asked Brown. Green said he interpreted some of the commercial zoning language to allow for similar uses. Comstock said he wanted to hear from Grant and Coel on Green's points. “Whether this would be similar to a pharmacy, I disagree with that type of interpretation,” said Coel, noting that a pharmacy has a licensed pharmacist and retail facility. “It's just a different setup than a storefront collective or dispensary.” Rushing said she was concerned because she didn't intend for them to discuss the zoning ordinance, just the moratorium. Grant recommended they leave that language alone, since it could potentially limit future discussions on that point. Green also suggested that the language about which dispensaries would be affected was ambiguous. He said it should be made clear that, from this point forward, no new dispensaries or collectives should open. During the discussion Grant clarified that the draft ordinance was meant to keep in force a stay of

enforcement against the six establishments that had received notices of violation. “The board is perfectly able to freeze it as of today,” she said, but they should set operations standards in case people try to argue about when they really opened. Brown said it was better to leave the language the way it was so that those outlets that had received the notices could still operate. Of the ones that have opened since the spring notices went out, Brown said, “They acted at their own risk, and they're not allowed. Until we get this ordinance figured out, they're not allowed.” Green said some of them may not have understood that they were opening at their own risk. Supervisor Anthony Farrington said all dispensaries should comply with state law, and if they do they should be allowed to operate. An additional suggestion by Green and Robey was meant to address those concerns, he said. He also suggested having collectives and dispensaries show proof of operation. Of the nine community members who spoke, seven were for the moratorium and two against. Middletown resident Fletcher Thornton said he wanted to see the temporary moratorium go into effect so rules could be established. He said there's a new dispensary on Main Street in Middletown, 150 feet from a school. “Don't tell me it's not allowed, because it's there,” he said, adding he'll ask the Middletown Area Town Hall to make suggestions to the board about how to zone dispensaries. Ronda Mottlow said she didn't support the moratorium, which she said was just another way to deny access to medical patients in need. Considering the county's rural nature, Mottlow said concentrating the establishments in the cities is a disservice to the people who need the drug. Dave Moses, managing partner of all Alternative Solutions dispensaries from here to Los Angeles County, also opposed the temporary moratorium. He said a community committee needs to be established in Lake County, as has been done in other areas, to draft rules. He accused Brown of benefiting from marijuana-related arrests from his bail bonds business, and also referred to the problems Brown has had on his property with illegal marijuana growers. After Moses left the microphone, Brown defended himself, saying no one growing marijuana on his property was involved with medical marijuana, and his private business is irrelevant to the discussion. Moses started making comments from the back of the room as Brown was speaking. “If you wanna say something come up here and say it. Don't pop off from the back,” Brown replied. Rushing told Moses he had to stop yelling from the back. When he didn't stop, she used her gavel for the first time this year. Other community members who are part of collectives said they favored the temporary measure. Diane Barkey of New Day Herbal Center in Clearlake Oaks said they sometimes give medical marijuana away free to those who need it. “We're here for the patient,” she said. Saying she supported the moratorium, Barkey added, “Most of us are in it for the right reasons, and I know we are.” Frank Molina, who owns a dispensary in Nice, echoed Barkey's sentiments. He said he's seeing a proliferation of collectives and dispensaries, and suggested it may be appropriate to set a limit for each area. Walter Zuercher, speaking on behalf of the Clear Lake Riviera Community Association, said they strongly support the ordinance. Dispensaries and collectives belong in places with good police protection, he said. Anita McKee, an area resident, said a dispensary recently reopened in a residential area in the Clear Lake Riviera. During its previous opening the area suffered crime issues, she said. The board unanimously accepted the urgency measure with Green's revisions, minus the addition of the word “explicitly” to the third paragraph. Rushing suggested they needed to agendaize a future discussion about forming a community committee to discuss zoning matters connected to dispensaries and collectives.

Fresno tries to stamp out pot dispensaries

Medical marijuana businesses crop up around town, with federal and state law at odds.

All of a sudden, medical marijuana has become a thriving business in Fresno -- in storefronts around town and in Superior Court. In recent months, at least nine dispensaries have taken root in the aftermath of a change in federal drug policy. Now city officials are asking a judge to shut them all down under a city zoning rule that the businesses say is impossible to comply with.....Simpson ordered the attorneys for all nine businesses to submit their arguments a week before the Sept. 17 hearing. But he sent clear signals Wednesday that he was leaning toward granting the city's request for an injunction, based on a recent appellate ruling in another medical marijuana case in Riverside County. "The conclusion looks virtually inescapable at this point that the operation of a medical marijuana dispensary in violation of the zoning ordinance is something that this court would be required to enjoin," the judge said. Whether he will change that view after hearing what the defense has to say remains to be seen. But their attorneys are confident that the law is on their side. "Ultimately, this will be decided in favor of the patients," Clark said. "We will get this sorted out."

Colo. medical marijuana users surge in number

DENVER - Colorado saw a record number of people register with the state as users of medical marijuana, which many attribute to the Obama administration's statement earlier this year that it did not intend to continue with federal raids on some marijuana dispensaries. Even though states have approved the use of medical marijuana, it does not change the fact that pot use remains prohibited by federal law. In May, 1,230 Coloradans were approved as "patients" who could obtain marijuana from a designated caregiver, providing they have a documentation of a diagnosis from a physician who is recommending marijuana for a debilitating medical condition. The May figure represents a significant surge from the 1,022 new patients in April, and is more than double the number for March, which was 602. The total number of patients who currently possess valid registry cards is 7,630. The average age of all patients is 24, and 72 percent of approved applicants are male. Those numbers are in-line with a similarly strong surge in the number of storefront clinics that dispense the drug, for complaints ranging from the effects of cancer to a category simply labeled "severe pain." Although the state does not license - nor does it keep track of - medical marijuana clinics, it is estimated that there are now at least 35 in the Denver metro area, where a year ago there were roughly a half dozen. "Amendment 20 and the laws and regulations that were put in place to support amendment 20, do not refer to dispensaries or clinics at all," Hyman said. "They are not mentioned whatsoever, and we have no relation with those entities."

Lab says marijuana use up in Hawaii workplace

Marijuana use in the second quarter was up 8 percent, to the highest level since 2004, according to statistics from Diagnostic Laboratory Services. Marijuana use was up from 2.3 percent in the first quarter to 2.7 percent in the second quarter of 2009, with 270 employees testing positive of the approximately 10,000 tested. "The positive rate for marijuana has increased during the recession to the highest level (2.7%) since Diagnostic Laboratory Services began keeping these statistics in 2004."

- Crystal methamphetamine: 0.6 percent, or about 60 employees, tested positive.
- Cocaine: 0.2 percent, or about 20 employees, tested positive.
- Opiates or prescription drugs: 0.2 percent or about 20 employees, tested positive.
- Marijuana: 2.7 percent, or about 270, employees tested positive.

Driver Survey Finds Less Drinking, More Drugs

Random roadside checks show that the percentage of people driving under the influence of alcohol appears to be declining, but many weekend drivers test positive for drug use. The findings come from the latest roadside survey by the National Highway Traffic Safety Administration based on breath, saliva, blood samples and questionnaires taken from randomly selected drivers in 300 locations around the United States. In 1973, 7.5 percent of drivers had a blood alcohol concentration of .08 or higher. (A level of .08 is above the legal limit in all 50 states.) In the latest survey, the percentage of people driving above the legal alcohol limit had fallen to 2.2 percent. For the first time, the roadside survey also used screening methods to detect marijuana, cocaine and prescription drugs. The survey found that 16.3 percent of nighttime weekend drivers tested positive for drugs. Nearly 9 percent had used marijuana, whereas nearly 4 percent tested positive for cocaine and a similar number had used prescription drugs. The drug tests only indicate the presence of the drug in the body and don't indicate when the drugs were used or whether the driver was impaired. The survey data showed that men were more likely to be impaired by alcohol than women. Drivers were most likely to be legally drunk between 1 a.m. and 3 a.m., compared with daytime or evening hours. The vehicles most likely to be operated by drunk drivers were motorcycles and pick-up trucks. The survey data were collected in 2007 from roadside locations throughout the country. Drivers were selected at random and waved off the road to a survey location by police officers, but the drivers were approached by interviewers who were not police officers. The drivers were assured that the survey was voluntary and anonymous. Of the 11,000 randomly selected drivers, about 90 percent agreed to give breath samples and 70 percent agreed to give saliva samples, said Jeff Michael, associate administrator for research and program development at the National Highway Traffic Safety Administration. The interviewers used extra incentives to encourage participation in the survey. Drivers were given \$10 for saliva samples and \$50 for blood samples. When a driver refused to take part in any of the testing, they were then offered \$100 as an added inducement. Only a few hundred drivers refused to take part in the survey. While that may suggest those drivers were impaired by alcohol or drugs, the numbers were small enough that they were unlikely to have a large effect on the data. In addition, because the same methods were used during each survey, the results are a useful indicator of driving impairment trends from year to year.....

Colorado's top doctor backs medical marijuana restrictions, says program 'out of control'

DENVER — Colorado's chief medical officer said Monday the state's medical marijuana program will "continue to grow out of control" unless more restrictive rules are adopted. Dr. Ned Calonge testified before the state health board in support of proposed new rules that would limit marijuana providers to five patients each.....Calonge, chief medical officer for the state health department, said those rules are creating confusion and the program is susceptible to fraud. He said large-scale marijuana growers busted by police are claiming to be medical marijuana suppliers. ***Calonge also said one doctor recommended that 200 people get medical marijuana cards in one day.*** The cards allow patients to grow their own marijuana or get it from a designated caregiver. Opponents say the limits would make it harder for patients to get medical marijuana.....

New Mexico's medical marijuana industry is about to bloom

Want to break into the marijuana business? You too can learn how to grow it, cook it, distribute it and, best of all, it's 100 percent legal. If Canntechs were to advertise on late-night television, that might be the pitch. As early as next month, the new company plans to offer training courses on New Mexico's medical cannabis laws and its emerging marijuana industry. The basic-level class—which includes cultivation, cooking and New Mexico-specific legal issues—will cost \$324.75 plus tax, according to the curriculum posted online at canntechs.com. In late December, the New Mexico Department of Health passed a series of rules that allow nonprofits to apply for licenses to grow and distribute pot to card-carrying medical cannabis patients. Canntechs is a for-profit company and won't be handling marijuana directly. Instead, Canntechs will serve as an all-purpose consulting and education firm, which will train the workers to fill jobs in growhouses and dispensaries, help patients register for the state program and help nonprofits craft their license applications.....

Trooper stops mobile pot crop

A state trooper making a traffic stop on Interstate 80 on Thursday discovered a mobile marijuana-growing operation — complete with fluorescent lights — in the car's trunk. ***Trooper Greg Goltz said he noticed several canning jars that contained a total of 18 packets labeled as California medical marijuana, including brands such as Maui Wauai, Sour High, and Cheese,*** complete with a picture of a chunk of cheese. When Goltz searched the trunk of David Herman's car, he found 13 plants in two rubber totes with ice, a working fan, a digital thermometer and fluorescent lights. Wires that ran to the front of the car brought battery power to the contraption. ***Authorities also found business cards from California medicinal marijuana sellers and receipts for ice from California and Utah.*** Goltz, a 21-year patrol veteran, had never seen such a garden in the back of a car. "I guess you can do anything," he said. "It's just (that) somebody actually did it on this one." Goltz said such medicinal marijuana can be sold for \$7,000 to \$10,000 per pound in areas where the drug is illegal.....

Mexico Legalizes Drug Possession

MEXICO CITY (AP) — Mexico enacted a controversial law on Thursday decriminalizing possession of small amounts of marijuana, cocaine, heroin and other drugs while encouraging government-financed treatment for drug dependency free of charge. The law sets out maximum “personal use” amounts for drugs, also including LSD and methamphetamine. People detained with those quantities will no longer face criminal prosecution; the law goes into effect on Friday. Anyone caught with drug amounts under the personal-use limit will be encouraged to seek treatment, and for those caught a third time treatment is mandatory — although no penalties for noncompliance are specified. Mexican authorities said the change only recognized the longstanding practice here of not prosecuting people caught with small amounts of drugs. The maximum amount of marijuana considered to be for “personal use” under the new law is 5 grams — the equivalent of about four marijuana cigarettes. Other limits are half a gram of cocaine, 50 milligrams of heroin, 40 milligrams for methamphetamine and 0.015 milligrams of LSD. President Felipe Calderón waited months before approving the law.

15 doctors behind most pot referrals in Colorado

DENVER (Map, News) - Statistics from the Colorado health department show two doctors are responsible for referring more than a third of the patients on the state's medical-marijuana registry. The Denver Post reports that of the roughly 10,000 medical-marijuana patients on the registry, 75 percent received their recommendations from one of 15 doctors. State health department director Jim Martin says it's a cause for concern. Colorado Attorney General John Suthers suggests that the state Board of Medical Examiners investigate the doctors recommending medical marijuana the most often to see if everything is proper. Cannabis advocates counter that the clustering of referrals is understandable, given that many doctors specialize in a particular area.

Man admits causing fatal crash while under influence of marijuana

Matthew Murray Kewitt admits that he was under the influence of marijuana when he caused a crash that resulted in the death of a child and pleaded guilty to vehicular homicide and negligent vehicular assault for the March 7, 2008 wreck near the intersection of Central Avenue and Florine Lane. A 24-year-old man admitted Monday that he was under the influence of marijuana when he caused a crash that resulted in the death of a child. Kewitt was driving a pickup truck at 7 a.m. when he suddenly turned across oncoming traffic and struck a car driven by 19-year-old Alyssa Kline, who was seventh months pregnant. Kline was seriously injured, and her baby was delivered by emergency Cesarean section. The child, Ryeli Kline-Embry, died nine days after the crash. During his court appearance, Kewitt answered questions from his attorney, Michael Moses, about the crash. Kewitt acknowledged that he had ingested marijuana the night before and into early morning, admitting that the marijuana diminished his ability to drive safely. Kewitt also said he failed to clear frost from the entire windshield of his truck, limiting his vision as he drove. As part of a plea agreement, prosecutors will recommend that Kewitt receive a sentence for vehicular homicide of 15 years with the state Department of Corrections with 10 years suspended and a \$10,000 fine. The agreement calls for a suspended 10-year prison sentence for the negligent-vehicular-assault charge, and Kewitt will be ordered to pay restitution. . . .
