

**AMENDMENT NO. 4 TO CONSULTING SERVICES AGREEMENT BETWEEN
THE CITY OF SAN LEANDRO AND
BKF ENGINEERS
FOR
MACARTHUR BLVD / SUPERIOR AVE ROUNDABOUT DESIGN PROJECT**

This **Amendment No. 4** (“Amendment”) is made by and between the City of San Leandro (“City”) and BKF Engineers (“Consultant”) (together sometimes referred to as the “Parties”) as of _____, 2020, and amends that certain Consulting Services Agreement (“Agreement”) dated May 13, 2016, between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to Civil Engineering design services for the development of construction-ready plans, specifications and estimates for the MacArthur Blvd / Superior Ave Roundabout Design Project, and

WHEREAS, the Parties desire to amend the Agreement to add surveying, mapping and coordination services related to the de-certification of right-of-way needed from Caltrans for project construction.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

1. Section 2 of the Agreement entitled “Compensation” is hereby amended to pay Consultant a sum not to exceed ONE HUNDRED SIXTY-FOUR THOUSAND THREE HUNDRED DOLLARS (\$164,300); and

2. Exhibit A of the Agreement entitled “Scope of Services” is hereby amended to include the following changes:

Addition to Task 1 – Project Management and Coordination

The Consultant shall coordinate with the Right-of-Way Unit of Caltrans to ensure that the right-of-way transaction moves forward related to the Caltrans de-certification. Tasks include meetings, phone calls and emails as needed.

Addition to Task 7 – Right-of-Way Surveying and Mapping

The Consultant shall prepare a plat, legal description and closure calculations in compliance with Caltrans standards to support the acquisition of the land parcel from Caltrans. Also, Consultant will prepare a Director’s Deed to be presented to the CTC.

Consultant will prepare the documents described above and submit them to Caltrans for review. The scope of work shall also include the discussion of review comments with Caltrans and revising documents as needed for approval. Two reviews are anticipated before approval will be obtained.

3. Exhibit B of the Agreement entitled "Compensation Schedule & Reimbursable Expenses" is hereby amended to read as follows:

Compensation for the work identified in Exhibit A shall not exceed \$164,300.00 as outlined below:
