However, they have the following definitions: Under section 5-42.02(v) within their Tobacco retail licensing chapter, <u>"Youth-oriented facility"</u> means a location or parcel in the City that is occupied by: (1) A private or public kindergarten, elementary, middle, junior high, or high school; (2) A library open to the public; (3) A playground open to the public; (4) A youth center, defined as a facility where children, ages six (6) to seventeen (17), inclusive, come together for programs and activities; (5) A recreation facility open to the public, defined as an area, place, structure, or other facility that is used either permanently or temporarily for community recreation, even though it may be used for other purposes; (6) A park open to the public or to all the residents of a private community; or (7) A licensed child-care facility or preschool other than a small-family day care home or a large-family day care home as defined in California Health and Safety Code Section <u>1596.78</u>.
