AMENDMENT NO. 3 TO CONSULTING SERVICES AGREEMENT BETWEEN THE CITY OF SAN LEANDRO AND NICHOLS CONSULTING ENGINEERS FOR

ANNUAL STREET OVERLAY/REHABILITATION 2019-21 PROJECT

This **Amendment No**. 3 ("Amendment") is made by and between the City of San Leandro ("City") and Nichols Consulting Engineers ("Consultant") (together sometimes referred to as the "Parties") as of _______, 2021, and amends that certain Consulting Services Agreement ("Agreement") dated June 17, 2020, between the Parties.

WHEREAS, City and Consultant have executed the Agreement, pursuant to which Consultant has provided certain consulting services to City with regard to the Annual Street Overlay/Rehabilitation 2019-21 Project, Project No. 2020.0050; and

WHEREAS, the Parties desire to amend the Agreement to include additional design consulting services.

NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties hereby agree to amend the Agreement as follows:

- 1. Section 1.1 of the Agreement entitled, "Terms of Services" is hereby amended to extend the term from December 31, 2021, to December 31, 2022; and
- 2. Section 2 of the Agreement entitled "Compensation" is hereby amended to pay Consultant a sum not to exceed One Million, Twelve Thousand, Five Hundred and Twenty Five dollars (\$1,012,525); and
- 3. Exhibit A of the Agreement entitled "Scope of Services" is hereby amended as follows::

Additional effort for Aurora Drive pavement design from Williams Street to Marina Blvd.

Additional permitting effort for improvements at the UPRR crossing north of Olive Court on Hesperian Boulevard due to extension of complete streets work on Hesperian Boulevard from Thornally Drive to Fairmount Drive.

Task 2A – Pavement and C&G Condition Survey

Additional effort for Aurora Drive pavement design from Williams Street to Marina Blvd.

Task 2C Pavement Coring

Additional effort for Aurora Drive pavement design from Williams Street to Marina Blvd.

Task 2D Pavement Design Recommendations

Additional effort for Aurora Drive pavement design from Williams Street to Marina Blvd.

<u>Task 3A, 3B, and 3C Design Data Gathering, Top Survey and Prelim Design, and Utility</u>

Coordination

<u>Task 3G – Complete Street Elements:</u>

Additional effort to conduct the complete streets traffic analysis and incorporate the complete streets improvements into the drawing set. Additional effort to extend the complete street improvements on Hesperian Boulevard from Thornally Drive to Fairmount Drive.
