Vicente Zuniga, Recreation and Parks Director, reported on the following: The MLK Oratorical Festival and Poetry Slam will be held Saturday, January 17 from 10:30 AM–12:30 PM at the Marina Community Center, featuring student performances (Grades 3–12), West African dance, music, and light refreshments; RSVPs are still welcome and one additional judge is needed. The Steven Taylor Sanctity of Life Pavilion Ribbon Cutting will take place Saturday, January 24 at 10:00 AM at Marina Park, including speakers, music, refreshments, and the unveiling of the public art piece “Life Force.” Spring

programs and summer camp registration opens early this year, with resident registration beginning January 17 and general registration opening January 24.

4.B. Parks and Urban Forestry

The North End drainage improvement project at the park has been completed, which will improve playground usability during wet weather. Field reservation timelines have been extended, and Recreation and Parks staff will focus on turf durability and field maintenance prior to reservations opening in February. The Parks and Urban Forestry Division now has two certified arborists, strengthening in-house expertise and supporting implementation of the Tree Master Plan. These updates reflect continued progress in park infrastructure, field readiness, and urban forestry capacity.
