## RESOLUTION TO AUTHORIZE THE CITY MANAGER TO DOUBLE EXISTING REWARD AMOUNTS FOR INFORMATION LEADING TO THE ARREST AND CONVICTION OF THE INDIVIDUAL(S) INVOLVED IN THE OCTOBER 9, 2010, DOUBLE HOMICIDES OF MAURIUS ROBINSON AND KWAME NUNN TO \$20,000; THE MARCH 22, 2013, HOMICIDE OF DELUN "ALLAN" PAN TO \$20,000; OR THE DECEMBER 14, 2014, HOMICIDE OF JOEL RAMIREZ TO \$100,000

WHEREAS, in a civilized society there is little that offends common decency more than the blatant act of murder; and

WHEREAS, on October 9, 2010, Maurius Robinson and Kwame Nunn were attending a party at the Monarch Bay Golf Course when they were both shot and killed; and

WHEREAS, although the City Council authorized a reward of \$10,000 for the apprehension of any individual(s) involved in the homicide on November 10, 2010, the homicides remain unsolved; and

WHEREAS, on March 22, 2013, Delun "Allan" Pan was shot and killed in front of his mother-inlaw's home in the 15500 block of Harbor Way; and

WHEREAS, although the City Council authorized a reward of \$10,000 for the apprehension of any individual(s) involved in the homicide on March 25, 2013, the homicide remains unsolved; and

WHEREAS, on December 14, 2014, Joel Ramirez was shot and killed while seated in his vehicle in the driveway of his home in the 400 block of Kenilworth Avenue; and

WHEREAS, although the City Council authorized an initial reward of \$25,000 for the apprehension of any individual(s) involved in the homicide on February 17, 2015, and then doubling it to \$50,000 on February 1, 2016, the homicide remains unsolved; and

**WHEREAS**, a City is authorized by Government Code section 53069.5 to offer and pay a reward for information leading to the determination of the identity and the apprehension of, any person whose willful misconduct results in injury or death to any person or who willfully damages or destroys any property.

NOW, THEREFORE, the City Council of the City of San Leandro does RESOLVE as follows:

That the reward leading to the arrest and conviction of the individual(s) involved in the double homicide of Maurius Robinson and Kwame Nunn be raised to \$20,000; and

That the reward leading to the arrest and conviction of the individual(s) involved in the homicide of Delun "Allan" Pan be raised to \$20,000; and

That the reward leading to the arrest and conviction of the individual(s) involved in the homicide of

## Joel Ramirez be raised to \$100,000; and

If more than one person provides information to law enforcement officials, which leads to the arrest and conviction of individual(s) responsible for any of these homicides, the reward will be paid to the person who provides information to law enforcement officials first, as determined in official documents of the homicide investigation. The Police Chief shall determine the right to receive the award based on the foregoing; and

A City Council approved increase to the current reward amounts would be funded through the current Fiscal Year 2024-2025 budget appropriation approval from City Council in account 010-14-015.
