Rich to adopt a resolution of the Planning Commission approving a Conditional Use Permit, Administrative Site Plan Review, and Administrative Exception (Height), 880 Doolittle Drive PLN22-0039 with a modification to Condition of Approval 31 to read as follows: "Truck and Vehicle Access. All commercial trucks shall enter and exit the site from the Hester Street driveways. No commercial trucks shall enter or exit the site from the Doolittle Drive driveway. Vehicle turning movements shall be restricted to right-in and right-out only at the Doolittle Drive driveway. Signage shall be installed indicating these restrictions to the satisfaction of the City Engineer."
