- 1. Section 1.1 of the Agreement entitled "Term of Services" is hereby amended to extend the term from March 10, 2022, to April 30, 2024; and
- 2. Section 2 of the Agreement entitled "Compensation" is hereby amended to pay Consultant a sum not to exceed \$120,523.20 and
 - 3. All other terms shall remain in full force and effect.

This Amendment may be executed in multiple counterparts, each of which shall be an original and all of which together shall constitute one agreement.
